SECTION 10. ALL CUSTOMERS METERED. NO FREE SERVICE. It shall be mandatory for all customers of the gas and waterworks system to be metered, and the schedule of rates herein prescribed shall be uniformly charged to all customers of the gas, waterworks and other liquid wastes being discharged into the municipal sewer system from any premises.

SECTION 11. METERS READ MONTHLY. Gas and water meters shall be read monthly commencing on the 15th day of each calendar month or as soon thereafter as weather and other conditions and circumstances may reasonably permit, and such reading shall continue as expeditiously as possible until all of the meters have been read.

SECTION 12. DEPOSITS. A deposit of ten Dollars (\$10.00) shall be made with the City by any applicant desiring water service. The following deposits shall be required of customers of the municipal gas system:

SECTION 20. MULTIPLE RATES. SECTION 21. RECORDS AND AUDITS. The rates, rentals and charges for the use of services rendered by the combined municipal gas, waterworks and sewer systems shall be billed and collected by the City, and the full amount of the proceeds and other services shall be deposited, as received, and set aside for the special fund designated in such manner as may be provided in any ordinance which may require but subject to any different provisions herein contained in any ordinance relating to the issuance of Revenue Bonds the records of the City with respect to charging, collecting and accounting for gas, water and sewer service shall be audited at least once each twelve months by an independent licensed public accountant, and a report thereof shall be filed with the City Council at such place, in such manner and at such time as may be provided in any ordinance relating to the issuance of Revenue Bonds. The records of such audit shall be open to the inspection of any person at any time, and the expense of operation and maintenance of said system shall be ascertained and collected by the City.
