Jim Gill, Senior Receives All-State Football Award

Jim Gill, senior at Nicholas County High School, received the All-State Honorable Mention Award for football. The award is given by the Courier-Journal and Louisville Times.

Gill, son of Mr. and Mrs. James Gill, was selected by voters from the Courier Journal Staff, coaches, and officials around the State of Kentucky.

He played offensive tackle, guard and center; he also played defensive guard, tackle, end and middle linebacker.

Grand Jury Returns Four True Bills

Four indictments were returned by the Nicholas Circuit Court grand jury at its final session after the February term convened Monday, but names of persons indicted were withheld pending serving of warrants.

Judge John P. Lair of Christians opened the court term, empaneled a grand jury of six men and women and instructed the panel to investigate all reports of law violations brought before it.

One trial, scheduled for Wednesday on the basis of a year-old indictment, was continued until the next term of court because of inability to locate the main complaining witness. The case is that of Marian Hopkins, about 50, of Nicholas County who was indicted Feb. 3, 1968, on a charge of striking with a deadly weapon with intent to kill.

Hopkins, who is free on bond, is accused of striking Ralph Robinson, also of Nicholas County, with a fire tool.

Council Petitioned To Annex Henryville

Orlando White, spokesman for a delegation from Henryville, petitioned City Council Tuesday night to annex Henryville into the City of Carlisle.

White presented the petition with the names of 33 property owners affixed to it. He said a similar petition was presented 7 years ago with 46 signatures. This represents a two-thirds of Henryville's property owners since that time, he said.

Since the city will be annexing one side of Dixieville Street when the housing project is erected, White asked that the rest of Henryville be annexed at the same time.

Dr. Robert Sparks suggested that a study be made to determine what the cost would be and what the potential revenue would be. Mayor Bill Power stated that such a study had been done previously and would be consulted. The Mayor scheduled a Council Meeting for Tuesday, Feb. 23, to discuss the petition after further study.

Mayor Power stated that the City has applied for the quantity of gas which Blue Grass Knitting has estimated it will need in the next five years for its expansion project.

There will be a Council meeting next Tuesday, Feb. 11, at 7:30 p.m. with Howard K. Hill reporting his findings relative to the water needs of B.G.K.

According to B.G.K. estimates, the following water requirements are necessary: 37,000 gallons a week using 2,680,332 gallons per month; it will require 1,000,000 gallons by Dec. 1967; 16 Dec. 1970, it will produce 27,207,000 gallons per week using 1,810,104 gallons per month; in Dec. 1975, it will produce 100,000,000 gallons per month.
