Several farmers here had trouble with mosquitos and gnats in their tobacco plants. Mosquitoes, blue-line mosquitos will also control tobacco diseases. To prepare blue-line-mosquito mixture: (1) Fill a clean 30-gallon barrel or oil drum 3/4 full of water strained through a cloth. (2) In one container thoroughly mix a pound of fresh commercial fertilizer time in 2 or 4 gallons of strained water. (3) In another container dissolve 3 pounds of powdered blue-line in about 4 gallons of water. (4) Pour the lime paste into the barrel of water and stir vigorously.

Apply without removing the cotton cover with an ordinary sprinking can. Sprinkle each time the sprinking can is filled. Fifty gallons will treat 140 running feet of bed 7 feet wide, or 100 running feet of bed 12 feet wide. Sprinkle plants and plowed area on each side and on the ends for a distance of 2 to 3 feet.
