"Seen Any Wildlife Lately?" is the provocative theme of the 32nd annual observance of National Federation Wildlife Week, March 15-21, sponsored by the National Wildlife Federation in cooperation with state affiliates.

William F. Threlkeld, District Conservationist, USGS, Soil Conservation Service, said the theme of this year's observance is particularly important because it asks each of us to reflect on our nation's vanishing wildlife heritage and ponder the effect on our own lives.

Increasing air and water pollution, persistent pesticides, non-planned highways, and urban sprawl are steadily gnawing away at our nation's wildlife resources.

A staggering 89 American wildlife species are on the brink of extinction.

With the accelerating deterioration of our urban and suburban areas, about the only wildlife most of our citizens have seen lately are rats, sparrows, pigeons and house flies.

During Wildlife Week, the National Wildlife Federation's 2 1/2 million supporters through the U.S. will be asked to "Seen Any Wildlife Lately?" and it is a reflection on the quality of our environment.

Wildlife is a sensitive yardstick for measuring the livability of our environment.

"Seen Any Wildlife Lately?" at first sounds like a simple-minded question, but in contrast with today's problems, it's loaded if you live out in the country (which most Americans don't).

chances are you can say, "Sure, I've seen a lot of wildlife lately, and start naming animals. If you live in a model city or one of the better-planned suburbs, you may have seen a variety of birds, some squirrels, and maybe a rabbit or a hawk; or lucky yet, you may have unpolished water nearby where you caught some fish last weekend.

Unfortunately, if you are like the average American, the place where you live has had too much wildlife lately.
