\$25 fee for sewer hook-up to be enforced by City

The \$25 sewer hook-up fee for each resident of Arnold Heights was discussed again at City Council's regular meeting Monday night. Attention was drawn to the fact that the trailer park at the City of Park had not individually been required to pay the fee. Council agreed to correct this oversight and to bill each of the trailer owners for the \$25 fee. In addition, Oliver Vice, City Operations Manager, was instructed to install water meters for each trailer at the park at present.

The April 10, 1971 contract with the owners of the trailer park was read. It stated that "standard monthly gas, sewer and water rates" would be paid.

Two ordinances were passed by Council after being read and after the required second reading.

One ordinance raises the City Attorney's salary from \$100 per month to \$150, per month. The other ordinance sets regular Council meetings on the second Monday of each month at 7 p.m., except for the first meeting in January after each city election. This meeting, which will be the next meeting of Council, will be on the first Monday in January as prescribed by law.

Kentuckians to file individual returns at new IRS Center

Louisville, Ky.—Robert J. Dath, District Director of Internal Revenue, announced today that Kentucky taxpayers will mail their Federal income tax returns in 1972 to the new Internal Revenue Service Center, Memphis, Tenn., 38110.

The first Kentucky Federal Tax returns for taxable year 1971 to be sent to the new Memphis Service Center are the income tax returns for individuals that will be filed on and after Jan. 1, 1972. Individual income tax returns include the following tax forms:

Form 1040 - Individual Income Tax Return
Form 1040 ES - Declaration of Estimated Income Tax
Form 1040 X - Amended Individual Return

Dath said business returns are not to be filed with the Memphis Service Center until July 1, 1972. Business returns include the income returns for corporations, partnerships, and fiduciaries, excise tax returns, and employer returns for social security, railroad retirement and income tax withholding.

These returns should continue to be sent to the Internal Revenue Service Center, Cincinnati, Ohio 45298 until the July 1, 1972 date.

The change in Service Centers from Cincinnati to Ohio, is necessary to equalize the returns processing workload which has increased nationally from 94 million in the early 1960's to 113 million in 1970. IRS projections indicate 131 million returns will be filed in 1980—a national 37 per cent increase during the decade. The number of Kentucky taxpayers is expected to reach the 1,700,000 mark in 1980 for a 37 per cent increase. Business returns from the area served by Memphis will be up almost 26 per cent during the same period.

According to Dath, the Service Center change will result in more efficient operations and quicker, more responsive service to Kentucky taxpayers. The Memphis Service Center is one of the largest and most technically advanced facilities in the nation. In addition to Kentucky, the Service Center will process returns from Tennessee and Virginia during the 1972 filing season.
