Try this—you will have about a cup of diced chicken.

**CHICKEN 'N CHIP BAKE**  
1/2 cup finely diced celery  
1/2 cup mayonnaise  
1/4 cup toasted almonds  
1 teaspoon grated onion  
Salt and pepper to taste and a bit of minced flour  
1/4 cup grated cheese  
1/2 cup broken potato chips  
Combine all ingredients except cheese and potato chips. Pile lightly in casserole and sprinkle with cheese and chips. Bake at 400 degrees until heated through. This will serve two or three. You can use leftover chicken and double the recipe easily and it is good, too.

Since chicken still seems to be the best buy in the way of meat, I welcome all new recipes. This one sounds particularly good. Chicken breasts, mushroom soup, grated cheese, green peppers, fresh mushrooms and condensed milk (large can). Brown 6 or 8 chicken breasts (halves) in oil or margarine. When brown place on paper toweling to remove excess grease.

In saucpan brown mushrooms and diced green pepper in about 2 tablespoons of butter. (One package of fresh or 1 jar of canned, drained mushrooms.) If you can get fresh mushrooms, wash and slice. Sauté about 15 minutes. Add mushroom soup and condensed milk, salt and pepper to taste.

Place chicken in large casserole, cover with sauce and add grated cheddar cheese about 1 cup. Bake approximately 1 hour at 350 degrees. Serve over rice or noodles. —Mrs. S. Evans Brown.

Here is another one that sounds good and is so easy. 1/4 fryer per serving. Wash and trim. Fryer each serving and roll or pat on a generous amount of oil. Fryer each serving in foil and bake at 350 degrees for 1 hour. —Mrs. S. Evans Brown.

Everyone seems to have a favorite recipe for chicken breasts, legs and thighs, but what to do with the rest of the chicken. When chickens are special, I usually get about three. After wrapping the favored parts for freezing in proper proportions, I would store at the wings, backs, etc., in a large bag and freeze. To make a long story short, you would be amazed at the delicious dishes that can be made from the "chicken in the plastic bag!" Here are a few ideas. Thaw and cover with water, salt 1/2 cup, and simmer until meat falls from bone. Remember this doesn't take long because these are fryer and tender. Lift meat and bones from stock. It is surprising how much meat you will have. (This is from three chickens.) There is still enough salad, using your favorite recipe. To the stock add enough onion to taste, a cup of cooked rice or noodles, and serve topped with croissants.

During these cold winter days, country style spare ribs sounds good. Boiled, baked or barbecued, sometimes par-broiled, then put under the broiler to brown and crisp. Have sometimes pot boiled ribs, drained, in baking dish in oven, brush with barbecue sauce, and when brown turn and repeat.

If you have plenty of time, place ribs in broiler pan so fat can drip through and bake about 300 degrees for about 2 1/2 hours or until tender, basting about every 15 minutes with barbecue sauce. Remember when buying spare ribs, choose those cut in approximate servings, ask your butcher to cut them for you. Other-

wise you will find them difficult to handle.

**BEEF SAUERBRATEN**  
1 1/2 pounds round steak, 1/2 inch thick  
1/2 minced onion  
1 tablespoon brown sugar  
2 tablespoons wine vinegar  
1 tablespoon Worcestershire Sauce  
1/4 teaspoon ground ginger

Enough water to make a medium thick gravy.

Cut meat in 1 inch square. Brown meat in 1/2 quart hot shortening. Remove meat from skillet to a 1 1/2 quart casserole. Add all other ingredients to skillet and bring to a boil, stirring constantly, before pouring over meat. You may want a bit more of the seasoning or a dash of Tabasco sauce. Don't forget the bay leaf will enhance in flavor as it cooks. Pour over meat in casserole, cover and bake at 300 degrees for 1 1/2 hours. When done remove bay leaf. Serve over noodles.
