## Girl Scout Cookie Chairman Named

Mrs. Joseph H. Conley has been named Girl Scout Cookie Sale chairman for Nicholas County. The over-all dates for the sale are March 11-April 3.

As in past years, the Scouts will sell five kinds of cookies—butter shorties, chocolate mint, peanut butter sandwich, assorting sandwich and pecanettes. The cookies will sell for 75 cents a box.

According to Mrs. Graydon A. Long, Lexington, Council president, the Girl Scout board of directors felt this increase necessary because of increased costs of the cookies themselves and the increased costs of providing services to Girl Scouts.

Ten per cent of the price of a box of cookies is retained by individual troops.

The remainder—which last year made up 24 per cent of the Council budget—is used to the outdoor program in the Wilderness Road area.

## Local Consumer Spending Rises

To get an idea of just how much the Nicholas County economy has grown in recent years, it is necessary to look back beyond 1970 and note the changes that have taken place.

The extent of that growth, since the beginning of 1965, is brought out vividly in figures released by Sales Management.

They show that retail business in the local area, a major indicator, went up 39 percent in the five-year period since 1965.

The gain was made despite consumer feelings over the war in Vietnam and despite domestic problems and higher taxes, which led them to be more conservative in their spending during the last year or two than they would have been.

The amount of business done by retail stores in the Nicholas County area rose from \$4,121,000 to \$5,727,000 in the five-year period.

## Reasons Given for Absence of 'Small Farm' Provision

The 1971 feed grain set-aside program was designed to give all participants several options while at the same time providing them with farm income protection, thereby eliminating the need for a special "small farm" provision, according to a local farm program official. Some inquiries have been received, he said, about the absence of a small farm program in the new feed grain program.

"If farmers keep in mind that this year's set-aside payments will be based on set-aside acreage and not on feed grain production, then they can see one big reason why a special provision was not included," said Harvey Waggoner who is Chairman of the Nicholas County Agricultural Stabilization and Conservation (ASC) Committee.

In earlier feed grain programs, he explained, participating farmers were required to plant feed grains in order to receive payments. Since many farmers who had bases of 25 acres or less seldom found it worthwhile to plant any grain, they did not qualify for these payments. To compensate, payment was made to them for required diversion. In this year's program, special provisions for the small farm
