Cost-sharing practices

Requests for conservation cost-sharing practices under the 1972 REAP are now being taken at the Nicholas County ASCS office, according to announcement by Harvey Wagner, chairman of the Nicholas County ASC Committee. As in 1971 emphasis is being placed on Rural Environmental practices and abatement of air, soil and water pollution. In addition to the provisions, 80% cost-share rate to low income families, 50% cost share rate applies to all participants for practices A-1 (establishing permanent vegetative cover) B-1 (improving or protecting permanent vegetative cover) and 1-2 (Soil and Chemical Runoff control measures). Requests must be made before practices are started and soil tests are required to determine the need of lime and fertilizer. Savings and loan to meet tonight

Stockholders of the Nicholas County Building Savings Association will hold their annual stockholders meeting Thursday, Feb. 3, at 7:30 p.m. at the office of the association.

All shareholders are invited to attend, according to John Allison, secretary of the association. Allison stated the association paid a total of \$9,617.80 to its members in 1971. The 121 members received checks ranging from \$1 to \$875.50 depending upon the number of shares held.

GI insurance to distribute \$7,000

Nicholas County residents who are World War veterans will have their finances improved by approximately \$7,000 this year by virtue of a special distribution of accumulated funds.

The money represents a stepped-up payment of dividends declared on their GI insurance policies. The issuance of such dividends, when available, is usually spread over the course of a year and paid to veterans on the anniversary dates of their policies.

This time, however, the payments will be accelerated so that all the money will be distributed within the next six months. The bulk of it will go out before April 15.

Sharing in the dividend, which comes to a record high of \$286,000,000, according to the Veterans Administration, will be 3,905,000 men and women who saw service in World War II and 154,000 who were in the first World War.

Only about a fourth of the 390 Nicholas County residents who were in those wars will share. They are the ones who hold National Life Insurance policies with a United States government Life Insurance. Veterans of other wars.

This hollow shaft is decorated from bottom to top with an elaborately carved spiral frieze in which more than 2,500 figures tell the story of Trajan's achievements. A golden urn, containing ashes of the Emperor, once topped the pedestal, but in 1587 it was replaced by the statue of St. Peter which you will see. Nearby Forum of Augustus and the Julian Forum built by Caesar in 50 B.C. are now somewhat less impressive.

Bootleggers raided here, in Bourbon

Three raids were made on bootleggers Saturday, Jan. 29, by State Troopers and State Police detectives from the Dry Ridge State Police post.

The first raid was made at the home of Brooks Bunsell, a half mile west of Carlisle on Ky. 32 at the Gallows Hill Road. Thirty-six half pints of whiskey were confiscated. The raid was made with the assistance of Bill Deltaris, Nicholas County sheriff between 19 and 11 a.m.

The second and third raids were made in Bourbon County. The one at Paris netted 20 half pints of whiskey, and the one at Millersburg, 20 half pints and two cases of beer.

Bunsell's trial is scheduled for today (Thursday).
