Court allocates Federal Revenue Sharing funds

The Nicholas County Fiscal Court is publishing in today's Mercury the planned use Report of Federal Revenue Sharing Funds for the fiscal year July 1, 1973, to June 30, 1974. The court is purchasing additional equipment at a cost of \$72,260 for use by the Nicholas County Road Department, which will replace used equipment now obsolete and in bad need of replacement. This equipment will consist of a wagon drill, three 1 1/2-ton dump trucks, one pickup truck, a bituminous distributor, and a payloader. With the purchase of this equipment the Nicholas County Road

Department should be in excellent condition to handle the road problems of Nicholas county. The court has also allocated \$72,420 for general government expenses and it is anticipated that these funds will be spent in a complete renovation of the court house which will consist of tack pointing on the exterior of the building, a new roof, remodeling certain structural difficulties in the upper part of the building, and redecoration of the interior. The court indicated that this should put the court house in good condition for many years of future use.

Father Kamlage to lead Guadalupe pilgrimage

"Visit Mexico—Christianity's birthplace in America" is the theme of the Nov. 10-21 pilgrimage to the Shrine of Our Lady of Guadalupe and tour of Mexico sponsored by the Shrine of Our Lady of Guadalupe, Carlisle, Ky.

The Spiritual Director of the pilgrimage will be the Rev. Herman B. Kamlage, Administrator of the Carlisle Shrine. His expertise of the Mexican Shrine and history will enhance the adventure south of the border. Pilgrims will fly to Miami, Fla., to board the luxury ship S/S Bolero for a three-day cruise through the Caribbean stopping at Puerto Merlon on the archeologically famed Yucatan Peninsula and Veracruz. Wherever the pilgrimage will drive to Mexico City for three days. Here the Shrine of Our Lady of Guadalupe will visit several times in addition to tours of the city and the Pyramids of Teotihuacan.

One day will be spent visiting Puebla and the Secret Convent of Santa Monica. Erroze to Acapulco, one night will be spent in Taxco, Mexico's silver city. After two nights on the Pacific Coast, pilgrims will fly home in time to spend Thanksgiving with their family and friends.

Teacher's salaries pass half million dollar mark

Salaries for Nicholas county teachers this year will total \$564,200, according to a salary summation approved last Saturday at the September meeting of the Nicholas County Board of Education.

Superintendent D. P. Parsley said the total reflected salaries for 66 regular teachers, one certified employee and seven employed under federal programs. In other business, the board approved the close estimate budget for the coming year by a unanimous vote and sent it to Fayette for state approval.

General Watkins and Ronnie Lecher appeared before the board and asked permission to use school facilities for the Little League basketball program this fall.

City to move offices back to City Building

City Council voted Monday night to vacate its present offices on Main Street by Nov. 1, so that Liberty Loan Corp. could move into them. The City will move back to the City Building behind the Courthouse.

The Public Assistance offices in the City Building will vacate the premises as soon as they can relocate. However, Council felt it could manage temporarily until this can be arranged. The City will be released from its lease on the Main Street building since Liberty Loan is willing to sign one.

Gerard Gerhard, Blue Grass Regional Crime Council Director, appeared before Council regarding ordering police radios at 25% of the cost. Maximum estimated costs for one unit was said to be \$12. Council voted 5-1 to purchase two units. Clifton Waugh voted against the motion. Council voted to donate \$150 to the Blue Grass Health Planning Council of which the City is a member.

James Carter asked Council to repair his yard which was dug up over a year ago for a sewer line. Mayor Bill Power said that the City crew would accomplish this work as soon as possible.

Bill Campbell addressed Council for the second time about a water bill that charges 49¢ difference between when Tommy Ring moved and a month and a half later when it was discovered that the water was turned on. City workers stated that they turned off the water when requested by Ring. Campbell said that 10 months later he discovered it on. No action was taken by the City.

Bill Small requested permission to place a trailer on his lot for his daughter and her husband's use. The request was

tabled until the residents in the area can be polled about the trailer. A City Ordinance prohibits trailers inside the city limits unless within a trailer park.

The National Guard letter, answering a request by the City to clean out Brassy Park, stated that the Guards were permitted only one project at a time. Presently, it is committed to the Recreational Park. After that, it has promised the high school to construct a track and field events area. The City was asked to submit a formal request so that it can be placed on the list of things to do by the Guards.

Bret and Willoughby, City policemen, were given raises of \$50 per month by Council.

Council voted to join the one-check payment plan of the First National Bank. Under this plan, the bank deposits each employee salary, figures all deductions, and submits receipts to the employee or the City whenever needed. The employee can withdraw his entire pay and deposit it in another bank if he wishes. No charge is made for this service by the bank. \$2,000 was transferred from the Revenue Account to the City Operating Account to help meet current expenses. Each year the Operating Account is short this time of year until taxes start coming in.

Two meter bids were opened. Council voted to accept Midstate Meter Supply's bid of \$67.39 with immediate delivery. The other bid was \$69.00 but delivery could not be guaranteed for six weeks.

A building permit was granted to the United Methodist Church to add a \$12,000 addition to its parsonage on Sycamore Hill.

Oleika Shrine plans Ceremonial, parade here

In early 1900 approximately 125 Shriners lived in the Blue Grass area. Their membership was in Kosair, El Hana and many other Temples. On Jan. 17, 1908 in Masonic Hall, Lexington, a

A meeting was held to explore the feasibility of chartering a Temple in Lexington. At this communication, a committee composed of William J. Cardwell, a native of Kentucky recently moved from Albuquerque, N.M. where he was Chief Habban of Bahai Atyad Temple), G. Allison Holland and Virgil Collins was selected to request permission from Kosair and El Hana Temple to set a charter for a new Temple in the Blue Grass area. After a series of meetings the necessary arrangements were made and on April 11, 1968 the name "Oleika" signifying "A Mountain in the Desert" was selected for the name of the Temple to be located in Lexington.

A number of years later a building lot was purchased on Scotland Drive. On June 1, 1969 ground was broken for the Mosque. A new addition was started in August of 1971. The addition brought Oleika's building to 24,000 square feet, double the original size.

In 1939, God must have touched the heart and mind of W. Frederick Kendrick when he launched the idea that the Shriners, as an organization, should do something for the friendless, orphaned and crippled children. This was the beginning of the philanthropy which was to become the World's Greatest—Shriners Hospitals for Crippled Children.

The money Shriners raise helps support the 22 Shriners Hospitals for Crippled Children—20 in the U.S. and 2 hospitals and three Shriners Burns Institutes.

The Shrine does not solicit funds for its philanthropies.
