The nursery schools have bedrooms, recreation programs, doctors, nurses, dentists and teachers and a.

At the end of the eight grade, each child must pass an oral examination given by three teachers. Then he has three choices: to go to work, to vocational school or to high school. If he goes to work, he is sent to vocational school for another 3 years by his employer. Everyone is expected to complete the equivalent of a high school education.

## Two UK Colleges ranked in top five

Michigan and the University of North Carolina.

The UK pharmacy school this year ranked fourth in the nation, up from fifth for the fifth place last year. The University of Wisconsin pharmacy school ranked third in the nation last year, now appears in seventh place. The University of California at San Francisco, Purdue, and Ohio State ranked first, second, and third in the nation.

Bliss and Margulies based their data on the collective judgment of the deans in each of those fields of study who responded to questionnaires sent to them by CURP. As in last year's survey, the deans were not asked to rank the schools but simply to list their five favorite deans in their field, and the rankings are based on the number of deans who mentioned a given school as one of the best.

Seventy-nine per cent of the deans listed responded to this year's survey, compared to 58 per cent a year ago.

**ORDINANCE RELATING TO ELECTIONS AT THE POLLS**  
 WHEREAS, the Fiscal Court of Nicholas County, Kentucky, deems it expedient to provide that elections be permitted at the polls in Nicholas County, Kentucky, on election day, and wishes to provide therefor pursuant to KLEWBE and K.R.S. 117.020; **NOW THEREFORE,** Be it ordained and enacted by the Fiscal Court of the County of Nicholas of the Commonwealth of Kentucky that:

Section 1: Electioneering shall be prohibited at all polling places in Nicholas County on election day, except that electioneering shall be allowed within fifty feet of the polls.

Section 2: Should any part of this ordinance be held invalid by a court of competent jurisdiction, the remaining parts shall be severable and shall continue to be in full force and effect.
