It gets a little uneasy wondering what might have happened that will affect our lives. We may even have had some news that we can scan them when we get home.

Conspicuously or unconspicuously we want to be reassured that nothing too calamitous has happened while we were out of touch.

We complain about the amount of "bad" news we read and hear. We may even be moved occasionally to condemn the press for printing and broadcasting so much of it. Yet if we think about it, in this country with its free press the "bad" news is actually reassuring.

Why? Because since we can be pretty confident the news media are going to tell us all the bad news around, we can also be pretty sure nothing worse than what are, all U.S. air crashes are reported by the nation's press. So we

Agree or Not

FRANKFORT, Oct. 7 (UPI)—The Court of Appeals may get a chance to decide whether it really meant what it said in its 1965 opinion that property in Kentucky must be assessed at 100 per cent of its fair value.

The chance will come on appeal from a decision handed down last week by Franklin County Circuit Judge Henry Meigs on a case filed in his court by school people. Judge Meigs ruled that 100 per cent of the assessed value of property should be used in computing the tax. The Department has been appealing, in part because it makes the printing plants.

Revenue Commissioner John McDiarmid says most of the counties in Kentucky have average assessments around 100 per cent of fair cash value, and the 100 per cent of fair cash value is being used in computing the tax.

After the court opinion, Governor Edward T. Brooke called a special legislative session and passed a law that just about negates the court's ruling. The compensating tax rate bill that passed said in effect that a branch of government couldn't get any more money from property than was assessed in the 1965 tax year.

The inquiry of assessments was transferred to legislative districts. The legislature has since then passed laws that have amended this somewhat and all growth in the counties are allowed as additional tax sources, hence more money for taxing districts.

Excluding values in property have been set for taxing districts. The legislature has been trying to keep their assessments up to a cash value. There seems to be a feeling that some property owners that check their property are getting the same rate as others, and the only way they can check is on Tuesday morning.
