Summer is cook-out time, and there is but one special occasion, just a pretty day and a little thought to perk up lagging appetites.

Here are some suggestions.

MARINATED DRUMSTICKS
 1/2 cup catsup
 2 to 3 tablespoons lemon juice
 2 tablespoons soy sauce
 1/4 cup salad oil
 1/4 teaspoon monosodium glutamate

Combine ingredients, add 12 chicken drumsticks. Let marinate for 24 hours, seeing that chicken is covered or turning occasionally so all drumsticks are covered. Can be marinated overnight.

When ready to cook, grill on slow coals about 25 minutes, basting with marinade. Turn, cook 25 minutes until tender. Baste often.

STUFFED BURGERS
 Make ground beef patties thinner than usual.

Center one patty with a tablespoon of diced cheese and pickle relish. Or use cheese and barbeque sauce, or cheese and a dash of horseradish sauce. Top with second meat patty. Seal edges well.

Brush with melted margarine and broil, turning once. Season with salt and pepper.

BACON-FRANKS
 Cut lengthwise slit in frankfurters.

Center one patty with a tablespoon of diced cheese and pickle relish. Or use cheese and barbeque sauce, or cheese and a dash of horseradish sauce. Top with second meat patty. Seal edges well.
