Fireworks can be no picnic

As the Independence Day holiday approaches, the Kentucky Society for the Prevention of Blindness has issued a warning that fireworks - all types and brands - are a threat to life and limb, and especially to eyesight.

Last year an estimated 7,800 eye clinic cases were taken to hospital emergency rooms to be treated for fireworks-related injuries. More than 17 per cent of the injuries were to the eyes, KSPB points out. This figure represents a fraction of actual injuries, because there is no way to estimate the number treated in doctor's office, at home or by direct hospital admission.

For many years, the Society has urged that use of all fireworks be restricted to licensed public displays, a number of which are enacted into law in many states and municipalities. Still, though fireworks appear regularly on street corners and in under-the-county sales.

Since the majority of fireworks violated injuries, more than 17 per cent of the injuries were to the eyes, KSPB points out. This figure represents a fraction of actual injuries, because there is no way to estimate the number treated in doctor's office, at home or by direct hospital admission.

KSPB says enjoy the holiday, but enjoy it safely.
