

Crop outlook termed good

Although heavy rains have damaged this year's tobacco crop, the outlook for the rest of Kentucky's farm produce is good, Agriculture Commissioner Tom Harris said last week.

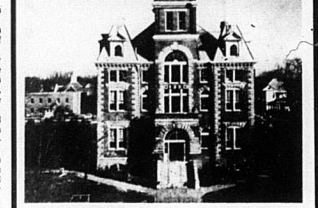
E.T. Reed, statistics director for the state Department of Agriculture, estimated the tobacco damage as the result of root suffocation from recent rains at between \$50 million and \$100 million.

Tobacco contributed nearly \$600 million to this year's total agricultural output of more than \$2 billion, Harris said in pointing out that barley tobacco was the state's third cash crop.

Reed pointed out that farming is extremely dependent upon the weather. It's one of the largest gambling operations in the United States," he said.

The state's other major crops, corn, soybeans and wheat generally fare better than tobacco during wet weather. However, some counties, like Bullitt, have suffered losses of corn and hay.

With cash receipts of \$134,299,000 from over 100 years, Kentucky ranks 17th in the nation in its production. Kentucky is the nation's biggest producer of white corn, which is processed

Kentucky adding jobs faster

A recent survey of eight southeastern states by the U.S. Department of Labor shows Kentucky's employment situation is improving fastest.

In February 1979 Kentucky added 22,500 jobs, compared to 21,500 in Florida. No other state in the survey came close to Kentucky's figure during the month. Mississippi was last with only 1,900 new jobs in February.

The survey, which was published in Florida Trend magazine, also showed Kentucky ranked second among the eight states in the number of new jobs in the one-year period beginning March 1978.

Kentucky added 96,300 jobs during that period, behind Florida with 147,700 additional jobs. Mississippi was last with 37,800 for the year.

State Commerce Commissioner Carroll Krieger attributes the improving job market in Kentucky to the business and labor climate.

"I feel the thrust is evident of a cumulative effort by the business and labor forces here," Krieger said. "It shows a fine initiative in industrial development, not only by the Commerce Department, but by the Kentucky Industrial Development Commission."

In another survey by the Conference of State Manufacturers Association (COSMA), Kentucky was ranked 12th among the 48 contiguous states in the number of manufacturing jobs gained from 1968 to 1978, with 56,000 additional jobs during those 10 years.

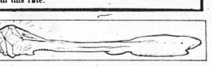
