### Jackets win fourth straight

Misery through the Nicholas County Bluejackets' season, their record stood at two wins and 10 losses. Times soon changed after the Jackets defeated the Deming Devils, 65-49, last Friday night at home, bringing their record to 8-13 and giving them a three-game winning streak.

An expert take from Mike Hutton to Mike Wells early in the first quarter gave the Bluejackets a 6-2 lead over the Devils. With the clock showing 2:32, Deming took an 8-8 lead, their first of the game. Nicholas soon caught up when the Jackets rebounded and Hutton took control of the ball, handing off to Mark Ruddle who hit his mark for a goal by Hutton. A rebound and goal try by Ruddle also failed. Finally as time ticked off the clock, Wells hit for a score to end the quarter with an 11-point lead for Nicholas County, 14-8.

To begin the fourth quarter Ruddle cannot two technical shots and a one plus one shot to shoot the Jackets score up four, 45-30. With 1:20 left in the game, the Jackets held a 20-point lead, 61-41. As one second remained in the game, Deming completed one basket to end the game, 62-41, with Nicholas County victorious.

Mike Hutton led the Bluejacket offense with a 27 total. Ruddle followed with 12, James Anderson had 10, Mark Rice had six, Mike Wells had four, David McGuffey had two, and Jerry Edwards had one.
