## U.S. farm exports set record pace

U.S. agricultural exports continued at a record pace in February, resulting in a total of \$11.8 billion for the first five months of fiscal year 1980, Thomas R. Hughes, administrator of the U.S. Department of Agriculture's Foreign Agricultural Service, reported today. The five-month total was up 36 percent from the same period a year earlier. Export values were above fiscal 1979 for all commodity categories except tobacco, according to Hughes. Corn export values soared 76 percent to \$2.3 billion, soybean shipments were up 16 percent to \$2.5 billion, and wheat and flour were up 43 percent to \$2.7 billion. Cotton shipments for the period were valued at \$1.5 billion, an increase of 75 percent from a year earlier. Soybean meat exports alone totaled \$1.3 billion, a gain of 31 percent.

## THE HOME GAME

SMOOTH RIDE - When drawers get balky about opening and closing, rub paraffin, candle or soap over the bottoms and the wooden strips that guide the drawers. Be 7/8 open and close like magic.

THE BEERIES - Limp, wrinkled fabric balls can be a really rejuvenated by wearing by using a jar of starch before drying.

SHARP PAINING - A sharp pinning knife is essential but sometimes dangerous to the thumb. To prevent nicks and cuts, cut out the thumb portion of a protector. Also helps when you use your grater.

THE BEERIES - Spring toast Mix 1 package coconut cream instant pudding with 1/2 teaspoon lemon extract. Fold one cup pudding, reserved for top. In paraffin or shorted glasses alternate pudding, sliced strawberries and crushed vanilla wafer crumbs. Top with remaining cream and chill.

TELLTALE TULIPS - Your tulips are trying to tell you something when they come up with only one leaf. It means they need dividing, so make a mental note to start digging next fall.

SNAG SHABBER - Some snags in knits can be caught by pushing a large-eyed needle under into the fabric next to the snag so the pulled thread can be threaded in the needle and pulled to the other side.

DIP AND DIPP - Wiping the paint brush across the rim of the pan can create bubbles. For a smooth finish, dip your brush no more than 1/3 its bristle length and tap lightly against the inner rim, above the paint level.

THE GREAT WORKUP - Old grease spots on wallpaper. They just come through on the next layer of paper. Thaw this by covering the spot with clear nail polish a day before repapering.
