

## John David Sims named director

Norma Linsell, executive vice president and chief executive officer of The Farmers and Traders Bank of Mt. Vernon, Ky., named John David Sims as director of the bank at their annual meeting Jan. 16, 1981. Sims, 50, is a partner in the firm of Sims & Sons, Inc., the bank's attorney and insurance agent.

Mr. Sims lives and practices law in Mt. Vernon, and is also associated with the law firm of Sims & Sons in Cincinnati. Mr. Sims graduated from Denning High School, University of Kentucky, and after five and one half years in the Air Force, returned to and graduated from University of Kentucky Law School.

All other directors who were re-elected are Oney Gillford, Eugene C. Linsell, G.A. Fannulus, Everett Morford, W.B. Sparks, E.C. Thomas and Norma Linsell.

At the director's meeting immediately following the shareholders meeting, all current officers were re-elected. Oney Gillford, president; Norma Linsell, executive vice president and chief executive officer; and John Adams, assistant cashier.

Norma Linsell reported that the bank had its best year ever with loans up 25 percent and assets up 25 percent to \$14,092,700. The bank's chief executive officer indicated that the reason for the growth was Norman Linsell's continued coming to the bank for personal installment loans and farm operating loans, plus depositors bringing their funds to their hometown bank.

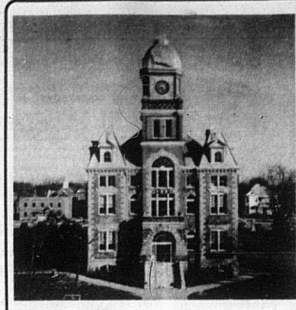
