Lawmaker's roundup

Round-up of pre-filed bills

HR 128. Sponsored by Rep. Dexter Wright, R-Louisville, the bill would require school teachers to lead pupils in one minute of silence at the commencement of each school day.

HR 129. Sponsored by Senators Wright, D-Harlem; Ed Ford, D-Cynthiana; Nelson Allen, D-Bellfonte; and Ed O'Daniel, D-Springfield, the bill would repeal prohibition charging a student any type of fee for participation in an instructional program.

HR 130. Sponsored by Rep. Roy Cyrus, D-Fairwood, the bill would include in the definition of energy utilities, city-owned electric utilities which operate outside the boundaries of the city; extend existing public and public hearing requirements to proposed transmission lines of 130 kv or more, rather than 60 kv; require that maps showing the proposed transmission line be included in the required notices; and require that a hearing be held near the location of the proposed line.

Legal changes for mentally ill

Two more opinions on the question of whether a verdict of "guilty, but mentally ill" should be incorporated into Kentucky law were heard by the subcommittee on mental illness and mental incompetence. A Jefferson Circuit Judge endorsed the mentally ill verdict, calling it a "stop-gap" that is needed even if the state lacks the facilities to house the criminally insane. However, a prominent Jefferson County attorney opposed the verdict saying it would create confusion among juries.

The subcommittee has been studying the mentally ill verdict issue for almost a year. A bill allowing the verdict has been pre-filed with subcommittee approval.

Another health and welfare bill also received full committee approval for pre-filing.

The bill changes the state's commitment law to reinforce the rights of people involuntarily committed to mental institutions.

The bill creates a hospital review committee of three mental-health professionals to review individual treatment plans when an involuntary patient refuses to participate, and allows a person facing a commitment hearing to have his own physician or health professional take part in the examination.

The bill was amended to require that two health professionals certify that an individual is mentally ill before committing court proceedings.

Recommendations for elderly

The Special Advisory Commission of Senior Citizens held their spring meeting at the State Capitol last week and agreed on a platform to be presented to the 1982 General Assembly.

Among the group's major recommendations are:

- A constitutional amendment to the state tax revenues to annual personal income.
- The enforcement of intangible property taxes be transferred from local property valuation administrators to the state Department of Revenue.
- Funding be continued for in-home services for the elderly.
- Pre-paid health plans be encouraged as a way to help contain rising health-care costs.
- A transportation program for the elderly in isolated and rural areas of the state be implemented.

Health insurance monitored

The state pays about \$50 million annually for Blue Cross-Blue Shield health insurance premiums for its employees and the Personal Service Contract Review Subcommittee has approved a contract to monitor those payments.

change the Readiness program for the upcoming year.
