Ambulance service will be re-shuffled

Blue Grass will pull out Jan. 1

Following agreement by the City of Carlisle Monday night to coordinate \$300 toward operation of the Nicholas County Ambulance Service next year, Judge-Executive Rose Smoot was hopeful that the same level of service could be maintained as in the past year.

The actions come in the wake of a letter from Blue Grass Medical Services to the fiscal court, informing the court that they "do not wish to renew the contract" and that, will be out of the ambulance service here at the end of December.

"Negotiations are going on right now with Larry Burton, who is presently an employee of Blue Grass Medical Services, to continue in charge of the service in the county," Smoot told the Mercury.

"The county has already agreed to put up \$10,000, along with the city's \$300 for one year to continue the ambulance service. The additional income necessary to run the ambulances would

come from the fees collected for the service.

Bad collection Citing only a 60% percent collection rate, Blue Grass Medical Services said their patient was for financial reasons, in that they were showing a loss for the year.

Under terms of a new agreement, Burton would continue to live in the quarters at the front of the old armory building and the city would pay the utilities on the building.

At Mercury press time, negotiations were continuing between Burton and the county over who will pay what share of the expenses of the ambulance, which already belong to the county.

Burton estimates that about \$10,000 in fees could be collected in a year and that this would be enough to keep things going.

Must have it "We have to have an ambulance

service," Judge-Executive Smoot said, "and even though some people think we could have a volunteer ambulance service, I am convinced that such a system wouldn't work. We have to have someone who is on call, and qualified, 24 hours a day. It's very few people that want to live under such an arrangement."

Fiscal court has moved their meeting date to Monday, Nov. 15, to discuss the ambulance issue, because of a conflict with dates later in the month, Smoot said.

The vote by the city to donate \$300 to the continued operation of the ambulance was a full-call, with Councilmen Magush and Cort voting no.

The council meeting was attended by Judge Smoot and Magistrates Adams, Fanch, Michael and Fryman.

Jailer sues

In joint action with nine other counties

The Kentucky jailers, including Lynn Bowles of Nicholas County, have sued their fiscal courts and county treasurers in a court action filed in Franklin Circuit Court at Frankfort, The Carlisle Mercury has learned.

The action apparently seeks to clarify interpretation of a new law affecting jailers, House Bill 146, which went into effect July 1, 1982.

The suit states, in part, "concurrent disbursement of jail operating funds by the defendants, the county treasurers, at the direction of the plaintiffs, the county jailers, as opposed to disbursement of said funds at the direction of the fiscal courts, and the adoption of an adequate operating budget for the jail by the fiscal courts."

The suit also seeks interpretation of the new law as it pertains to how the county jailers salary is computed and the duties of the jailer.

Named in the suit, in addition to the Nicholas Fiscal Court and the County Treasurer are nine other county fiscal courts and their treasurers, which include Franklin County, Anderson County, Crittendon County, Fulton County, Mercer County, Harrison County, Caldwell County, Garrard County and Marion County.

Nicholas County Attorney Jack Conroy said the county will ask that the suit be dismissed because of "improper venue," meaning the suit was filed in the wrong county.

"If the jailer wants to sue the fiscal court, the suit should be filed in that particular county, not in Franklin County," Conroy told the Mercury.

A hearing in connection with the matter has been set for Friday, Nov. 19, at 1:30 p.m. in Franklin Circuit Court.

Conroy said the county also contends that the suit is "not specific" and as a result, the county doesn't know what Jailer Bowles really wants.

Bowles, contacted by the Mercury, referred questions regarding the matter to the attorney who has filed the suit, Robert A. Bowman of Frankfort. However, it is known that Bowles has had a dispute with the county over funding for the jail.

Bluejackets end season whipping Bellevue 28-18

The Nicholas County Bluejackets completed their season with an impressive victory over the Bellevue Tigers. The Jackets led through the entire game; final score 28-18.

Reverend James Terry Ledford recovered a Bellevue fumble on the opening kickoff. A 15-yard pass from Anderson to McGuffey and a 13-yard run by Hopkins, scored Nicholas County's first points.

A 15-yard pass to Young from Anderson with Nicholas County on the one yard line, but a Nicholas County fumble possibly scored them back to the 15-yard line. From there, McGuffey passed to Ken Baker to score the touchdowns. Steve Anderson's run for the two extra points was unsuccessful.

Late in the first quarter, a pass interception gave Bellevue the ball, but their attempt for a 15-yard field goal failed. The first quarter ended with a Nicholas County fumble recovered by the Tigers, score 8-0.

Tiger J. Miller started the second quarter with an eight yard run for a Bellevue touchdown. The extra point

kick failed. Robert Hopkins scored the next touchdowns for the Jackets on a 25 yard run, and then ran for two extra points. Rick Buckler ran five yards to score a second Bellevue touchdown and the second quarter ended, score 14-11.

In the second half, Rocky Young recovered two fumbles. But the Jackets failed to gain the yardage they were forced to punt. Bellevue fumbled on the next return and Jacket Terry Ledford recovered. Steve Anderson carried 12 yards for a touchdown and his extra point pass to Young was complete. The third quarter ended with the score 21-11.

The fourth quarter began with a touchdown by Tiger Doug Miller, who ran one yard for the score. The attempt for a two point conversion failed. Hopkins scored Nicholas County's final touchdowns of the season and Jacket Terry Ledford scored the extra point run by McGuffey, leading the final score 28-14.

Individual offensive statistics are as follows: Robert Hopkins gained 165 yards on 14 carries, which extended his

total yardage for the year past the 1000 yard mark. Steve Anderson carried six times for 38 yards. He completed six of 11 passes for 40 yards. He caught one pass for 15 yards. Rocky Young recovered two of 10 passes for 30 yards.

Steve McGuffey carried seven times for 30 yards and one extra point. He completed and 40 yards. He caught the ball one time for 30 yards. Ken Baker carried three times for six yards. Ken Baker had one carry for 11 yards. Greg Robinson punted four times for 100 yards.

Terry Ledford led the Nicholas County defense with 28 tackles and a fumble recovery. Rocky Young had 11 tackles and two fumble recoveries. Dennis Allison made 10 tackles. McGuffey had seven tackles. Pat Pope made six tackles. Anderson, McGuffey and Duane Baker made five tackles each.
