Food prices rise; 6-month gain is modest

Retail food prices in Kentucky moved up 7.1 percent during June, closing out the first half of 1967 with a modest six-month gain of 5.1 percent, according to the findings of Kentucky Farm Bureau's market-basket survey.

The June increase brought the average cost of 44 selected food items to \$64.97, up from \$61.76 in May. By comparison, the June 1966 market basket cost was \$61.36, an increase of 6.5 percent over the June 1966 level.

Three of the four major food groupings moved higher during June. Meat and poultry advanced 8.1 percent, dairy products were up 7.1 percent, and grain and vegetable products were up 5.1 percent.

Meat and poultry products were up 8.1 percent, with beef and pork leading the way. Beef prices were up 10.1 percent, while pork prices were up 7.1 percent.

Dairy products were up 7.1 percent, with milk and cream leading the way. Milk prices were up 8.1 percent, while cream prices were up 6.1 percent.

Grain and vegetable products were up 5.1 percent, with wheat and corn leading the way. Wheat prices were up 6.1 percent, while corn prices were up 4.1 percent.
