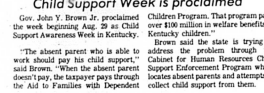

Gov. John Y. Brown Jr. proclaimed the week beginning Aug. 29 as Child Support Awareness Week in Kentucky.



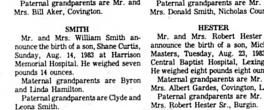

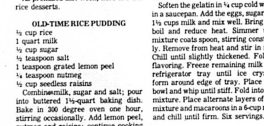

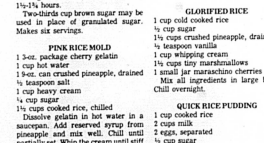

Non-emergency hospital admissions will need clearance from KPPO

Dr. Robert C. Burkhardt, president of the Kentucky Peer Review Organization (KPPO), announced that implementation of a prior authorization program for non-emergency admissions to Kentucky hospitals under the Medicaid program will be effective as of Sept. 1.

The program will require the admitting physician to obtain a non-emergency prior authorization number before admitting non-emergency patients to a hospital. The program is designed to reduce the cost of care for Medicaid patients.

The KPPO Board of Directors is expected to meet on Sept. 1 to discuss the program. The program is a result of a study conducted by the KPPO in 1982.

The program is designed to reduce the cost of care for Medicaid patients. It will require physicians to obtain a prior authorization number before admitting non-emergency patients to a hospital.
