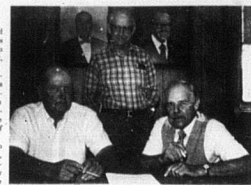

THE OFFICE OF THE CIRCUIT CLERK

In 1975, Kentucky voters passed a new judicial amendment to the state constitution which reorganized our court's system.

All the cases previously handled by police courts, county courts, quarterly and magistrate's courts, came under the jurisdiction of the new district court and became a part of the Circuit Clerk's responsibilities.

At that time, the Circuit Clerk became a state employee. The Circuit Clerk's Office and Courtrooms were rented from the county by the state. The Circuit Clerk and deputy clerks are paid by the state and the checks are signed by the State Treasurer.

Under the present court system the district court handles traffic offenses, juvenile matters, civil claims up to \$2500, probate of wills, felony pre-arrests and small claims.

Circuit Court has jurisdiction of capital offenses and felonies, divorce, child custody and adoption, land title disputes, contested probate of wills, all civil suits for more than \$2500, and appeals from district court.

The Circuit Clerk is responsible for the custody, control and safe keeping of court records for all the proceedings in both courts.

Among the Clerk's additional duties are the official filing of lawsuits and papers for the courts, being present during trials, receiving fines, handling bond money, operating electronic recording equipment in both courts and issuing driver licenses and boat registrations. Passport applications may be obtained and processed in the Circuit Clerk's office. Notary service is also available.

Most of you will someday visit the Circuit Clerk's office when you need a driver's license. If it's your first license, you must be 16 years of age; bring your birth certificate and social security card and if you are under 18, a parent or guardian who can sign that they will assume financial responsibility.

Not only does your Circuit Clerk handle a large workload that is critical to the judicial system's operation, the Clerk must also be accountable for the thousands of dollars which come through the Clerk's office for everything from bail bonds and jury fees to payments for driver licenses and boat registrations. Every penny of that sum must be accurately recorded and accounted for to the state auditor.

The Circuit Clerk's office wants to make the system work for you. If you have a question, we're happy to answer it...and if we don't know the answer, we'll find it.

The Circuit Clerk's Office is open Monday through Friday from 8:30 a.m. until 4:00 p.m., including the lunch hour. The office is open Saturday mornings from 9 a.m. until NOON to be of service to you.
