State only earns a grade of D

A report card, prepared by the House Ways and Means Subcommittee on Public Assistance, indicates that Kentucky earned a grade of "D" for its child support program.

In the Child Support Enforcement Amendments of 1984, the United States Congress amended the Social Security Act by adding a requirement that the states set up child support guidelines and make them available to all entities of the state who support awards.

Periodically review case files to determine if the award meets the guideline amount. Review and adjust amount of all child support cases, if necessary, every three years.

Notify parents of any proposed adjustments. By establishing this requirement of the Social Security Act, the Congress required the Department of Health and Human Services to impose a penalty on states which do not comply with the guidelines.

The penalty is set at the loss of all federal funds for operation of the child support enforcement program and a minimum of one percent of all federal funds provided to the state for payments under the AFDC program.

In Kentucky, this translates into a loss of approximately \$14 million in federal funds for the administration of the child support enforcement program and approximately \$1.5 million in AFDC to the Cabinet for Human Resources' Division of Child Support Enforcement.

Kentucky's Child Support laws mandate automatic withholding for all new and modified child support orders established after July 1, 1988. For many who have not had imposed for non-payment of support, including jail sentences for second and third offenders.

The definition of "felonious non-support" has been narrowed, making it possible to charge a non-custodial parent with a felony if he or she owes payments, or six months have passed without a payment, or the child has been placed in destitute circumstances due to child support delinquency.

Although the hurdles we face are significant, we are making progress. We must change societal acceptance of non-payment of child support. Kentucky's voters should applaud and support judges who levy stiff penalties against non-custodial parents that do not support their children.

Kentucky's county attorneys who have contracted with CHER's Division of Child Support Enforcement to provide local child support enforcement services face a difficult job.

With a lack of staff and resources, and mounting state and federal regulations, county attorneys daily face frustrated and angry parents who 95 percent of all custodial parents are women seeking support.

Generally speaking, caseloads are high and most county attorneys' offices are not yet computerized to handle these caseloads.

The enforcement effort of a number of counties is excellent; however, several counties desperately need improvement.

In order to improve enforcement efforts, county attorneys across the Commonwealth are developing a communications system that incorporates judges and sheriffs whose cooperation is essential.

Media coverage and an aggressive public awareness campaign have highlighted Kentucky's aggressive approach to child support enforcement and the problems that we face.

Through the enforcement of progressive legislation, including automatic wage withholding and utilization of statewide guidelines, we may restore dignity to the thousands of custodial parents across our state that need child support to sustain their families.

In recognition that our children are the future of our Commonwealth, by request of Attorney General Fred Cowan who serves as Chairman of the Child Support Enforcement Commission, Governor Wilkinson has proclaimed October as Child Support Enforcement Awareness Month to highlight the united efforts to provide support for our children and their future.
