

Nicholas County's Babe Ruth advances to finals of East Kentucky tourney

The Nicholas County Babe Ruth 14-15 year-old All Stars traveled to Paintsville this weekend for the East Kentucky State Babe Ruth Tournament. Our Nicholas County boys surprised everyone by winning three straight games and being the only undefeated team left for the championship game.

On Thursday, July 23, Israel Stacy pitched the full seven innings in the first game against Russell Flatwood. Israel allowed seven hits and gave up only three walks. The Nicholas County team came up with six hits, from Shane Kenney, Bradley Brown, Duane Kenney, Brian Smoot and Chris Kelley. This was enough to score five runs and good defense kept Russell Flatwood to four.

In the second game on Friday, our boys faced a tough Knott County team, Carr Park. Bradley Brown did the honors on the mound as he allowed five hits and walked only three. Hitting for Nicholas were: Shane Kenney, John Brown, Bradley Brown, Duane Kenney, Brian Smoot, Chris Kelley, and Mike French. The final score was Nicholas 5, Carr Park 2.

In the final game of the winners bracket, a smug, confident South East Lexington team took the field with comments that Nicholas would be beat in five innings by 10 runs. A fired up Nicholas County team along with several fans set out to prove them wrong. John Brown took the mound on Sunday, July 26 and hurled for a good five innings before being relieved by Israel Stacy. Lexington got the lead early in the game by scoring one run in the first and two in the second inning. Then the boys from Nicholas came alive. Mike Booth got a walk to lead off the third inning. This was followed by base hits from Mike French who bunted, Shane Kenney and John Brown. After walks for Duane Kenney and Brian Smoot, Chris Kelley hit safely. Mike Booth walked for the second time in the inning before the third out was made. Scoring five runs in the third put Nicholas on top 5-2. Lexington scored two runs in the fourth to tie the game. In the fifth inning, the rain stopped the game with Nicholas coming up to bat in the bottom of the fifth.

The game was finished on Monday, July 27. Nicholas failed to score in the bottom of the fifth even though Brian Smoot got another good hit. Excellent pitching by Chris Kelley, a sacrifice bunt

and came through with a base hit to bring in the winning run. This win put Nicholas County in the driver's seat as they go to the Championship game on Wednesday, July 29. The only undefeated team they know they've got a hard game ahead of them, but as confident they can come out on top.

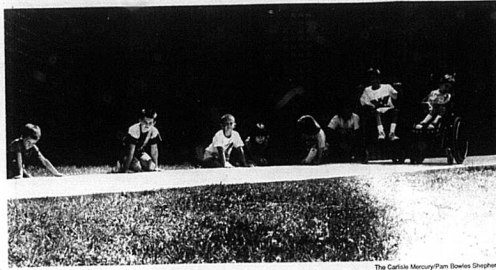

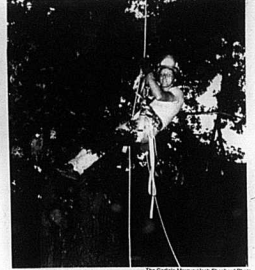

PUBLIC NOTICE

The Fiscal Court of Nicholas County, Kentucky, at a meeting commencing at 6:00 P.M., on August 11, 1992, to be held at CourtHouse, Carlisle, Kentucky, will consider for passage the following ordinance:

Whereas Division Systems and repairing electrical equipment are furnished with "Load" of Light Systems Installation and Approval Certificates from Nicholas County Health Department before issuing an order for permanent electric service to any newly constructed or newly located building in Nicholas County;

NOTICE WEED ORDINANCE

§2-03 CERTAIN CONDITIONS DECLARED A NUISANCE.

It shall be unlawful for the owner, occupant, or person having control or management of any land within the city to permit a public nuisance to develop thereon. The following conditions are declared to be public nuisances:

Weeds and grass. The excessive growth of weeds, grass, or other vegetation.

Unless otherwise provided, "EXCESSIVE" shall mean growth to a height of 12 inches or more.

§2-04 ABATEMENT PROCEDURE.

It shall be unlawful for the owner, occupant, or person having control or management of any land within the city to permit a public nuisance, health hazard, or source of filth to develop thereon.

Whenever a nuisance situation is discovered, the Police Chief shall give "five days" written notice to remedy the nuisance situation.

§2-09 PENALTY.

Whoever violated any provision of this chapter shall be fined not more than \$500.00 for each offense. Each day's continued violation shall constitute a separate offense.
