

NOTICE WEED ORDINANCE

92.03 CERTAIN CONDITIONS DECLARED A NUISANCE.

It shall be unlawful for the owner, occupant, or person having control or management of any land within the city to permit a public nuisance to develop thereon. The following conditions are declared to be public nuisances:

Weeds and grass. The excessive growth of weeds, grass, or other egetation.

less otherwise provided, "EXCESSIVE" shall mean growth to a height of 12 ches or more.

It shall be unlawful for the owner, occupant, or person having control unagement of any land within the city to permit a public nuisance, health mard, or source of filth to develop thereon.

Whenever a nuisance situation is discovered, the Police Chief shall giv ive days' written notice to remedy the nuisance situation.

Whoever violated any provision of this chapter shall be fined not more than \$500.00 for each offense. Each day's continued violation shall constitute a separate offense. (AM. ORD. 0-1988, passes 12-12-88)
