be termed "astronomical figures."  
Chairman Garvey Cartwright told Workman the board is billing customers for water that passed through meters but was only estimated by the company formerly employed by the board.  
"A lot of Lexington was reading the meters, or so we thought," said Cartwright. "We have found that they allegedly were not reading each meter but estimating. I think the increase in the amounts billed to customers was a one-time payment to

catch residents up to the amount of water used, versus the amount paid."  
Resident Gary Humphries expressed his concern to the board over a sub-number shown on his bill. Humphries said the meters are read from the left instead of right, so he was charged for every 10 gallons used.  
Board member Joe Kirby said several people listed as having not used water had been charged.
