ORDINANCE 6-1993
An ordinance levying City of Carlisle all motor taxes for general municipal purposes for the Fiscal Year July 1, 1993 through June 30, 1994, on motor vehicles and watercraft within the taxing jurisdiction of the City, on each one hundred (\$100.00) dollars of January 1, 1993, assessed valuation, sixpence and seven tenths cents (6.17).
Be ordained by the City of Carlisle:
Section 1. That for the purposes of support of the government of the City of Carlisle, and the payment of its debts and expenses for the Fiscal Year July 1, 1993 through June 30, 1994, there be and hereby are levied ad valorem taxes on each one hundred (\$100.00) dollars of the January 1, 1993 assessed valuation by the Nicholas County Property Valuation Administrator of all taxable motor vehicles and watercraft within the jurisdiction of the City, at the following rates and seven tenths cents (6.17).
