Survey to test literacy

FRANKFORT, Kentucky (August 18, 1994)—A survey will be conducted during the next several months that will assess the literacy level of Kentucky's adults.

The Cabinet for Workforce Development's Department for Adult Education and Literacy will use the survey results for literacy education campaigns, planning training programs and other initiatives requiring literacy data.

The Department has contracted with the University of Kentucky's Martin School of Public Policy and Administration to conduct the survey.

A consent form will be signed by each person who agrees to participate in the study and results will be confidential.

The 1993 edition of this directory will be mailed in December and will include residential and business listings from across Kentucky, as well as Alabama, Florida, Georgia, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.

Listings in the book are free of charge and are restricted numbers that can make or receive calls using telecommunication devices for the deaf.
