Company realizes first beginnings

In July 1974, the farm home of the Edward J. Dorsey family, located on Cranston Road, two miles from Flemingsburg, was destroyed by fire while Mr. Dorsey was away from the house. A new two story, eight room house was soon built, and the family moved into the new house in December, 1974.

The company has virtually kept its same status over the period of years. There are longer membership lists, and more insurance coverage. Insurance coverage is not limited to just farm buildings. Fire, lightning, wind and hail coverage is obtained on any dwelling or building.

In 1990, farm and personal liability became part of the coverage offered. Rates are affordable and there is no deductible. Premiums are assessed, as usual, according to the previous year's experience.

The company today has 2,500 policyholders and insurance in force has increased over the past 50 years, from \$3,450,000 to \$60,000,000. Coverage is provided not only for Flemingsburg, but also for those people in the Nicholas, Rowan, Lewis, Robertson, Bath, Menifee, and Mason Counties. The company is a member of the National Farmers Union of America.

Other Directors include: Noel Hester 20 years; James Dwyer, 20 years; Frank O. Hinton 43 years; Maurice Reynolds, 20 years; R.W. McInerney, 7 years; Dean McCann, 2 years; Doug Altherion, 13 years; Kenny Wigmore, 1 year; Chuck Sauer, 1 year; Gordon Denaiah, January 1974.

The Mutual Aid Association of Flemings County was formed to insure farm homes and buildings for Flemings County farmers. The premium is based on the losses, and from fire, wind, lightning, etc. membership was limited to this beginning, business did not commence until March 1, 1976.

The company became incorporated February 27, 1896. At that time, a charter was formed for 25 shares of stock for the property valued at \$50,000 or more. It was decided the company would be managed by a board of directors consisting of 11 members. Those members decided to meet on a regular basis. They were William Quantz, President; W.S. Fain, J.D. Cooper, Walter Worrick, J.D. Glawick, Robert Williams, R. Darnall, Andrew Porter, John W. Kelly, Bert Howard and Charles M. Kelly, Jr.

It was decided to insure farm buildings only and each policyholder would pay a \$2 membership fee. Premiums were assessed by the previous year's claims. During those early years if there were excessive claims, the policyholders would occasionally be billed twice during the year in order to pay the bills. The directors received very little pay for their services. They did not have a list of expenses for the company since they traveled by horse and buggy. There were no limitations on insurance. No building could be insured for more than \$5,000, if more coverage was required, a permit was issued for that policyholder to get additional insurance with another company. There was noough capital for the company to stand the risk. By-laws were made and carried out according to Kentucky Statutes. As late as 1920's, business was still slow. Monthly meetings were held at the Oldfield building in downtown Flemingsburg. Atlanta later Bob Darnall, who was President of the company and also President of the Peoples Bank, arranged for the meetings to be held at the newly remodelled bank. The company in later years moved to Main Street.
