**Bourbon General Health Fair**

PARIS: The Annual Bourbon County Health Fair will be held at Bourbon General Hospital from 8 a.m. to noon Saturday, Nov. 12.

Along with numerous free health screenings and information booths, the fair will offer a complete blood chemistry analysis for a fee of \$20, a cardiovascular risk profile for a fee of \$10, a cholesterol screening for a fee of \$5, a body composition check for \$5, and a T. B. skin test for \$2.

Participants must register for the tests by 11:30 a.m. on Saturday. Participants must not eat or drink of at least 12 hours prior to having the tests done for the most accurate results.

For those unable to have the tests done on these dates, Bourbon General Hospital will be offering rain checks for the tests to be done at a later date. Rain checks must be purchased on the scheduled health fair date.

While it is not possible to diagnose or treat any disease or problem with the blood tests alone, the test can help persons learn more about their body and detect potential problems in early stages when treatment or changes in personal habits can be most effective.
