### Wedco Health initiates child immunization program

The Wedco District Health Department has initiated an initiative program for children to get immunizations.

All children in Harrison, Nicholas and Scott County Health Centers who have received required immunizations, receive a T-shirt with a logo "I'm Immunized," as part of the "Every Child By Two" campaign.

By the age of two, every child should have received the following vaccines: diphtheria-tetanus-pertussis (DTP), diphtheria, polio, 3 doses, measles-mumps-rubella (MMR), 1 dose, usually 18 months of age, and 2 doses (depending on the type), usually this schedule is completed at birth and is completed by 15 months of age.

The "Every Child By Two" campaign was re-endorsed by Rowley Carter and Bill Blumens. It started during the Carter Administration with a goal of complete immunizations of all children by the age of two. Wedco asks that all parents and guardians should contact their private physician or local health centers to be sure their children's immunizations are up to date, and if immunizations are needed they should be received as soon as possible.
