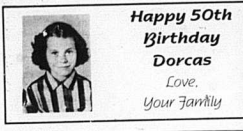

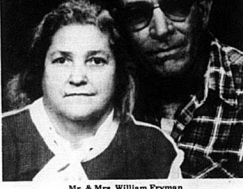

Frymans celebrate 50th

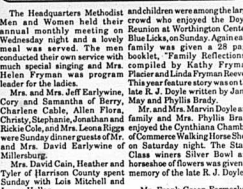
