AN ORDINANCE ADOPTING THE CITY OF CARLEISLE, KENTUCKY BUDGET FOR THE FISCAL YEAR JULY 1, 1996 THROUGH JUNE 30, 1997...

BE IT ORDAINED BY THE CITY OF CARLEISLE AS FOLLOWS: WHEREAS, a budget and message has been prepared and delivered to the City Council; and

WHEREAS, the City Council has reviewed such budget proposal and made necessary modifications,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF CARLEISLE, SECTION 1: The City of Carleisle hereby adopts and amends the following budget for 12 months ending June 30, 1997 as follows:
