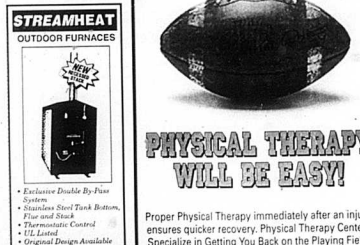

AN ORDINANCE relating to franchise fees on bank deposits which are held by all financial institutions within the county of Nicholas, for the health, education, safety, welfare and convenience of the inhabitants of Nicholas County.

SECTION 1. Definitions. A. "Deposit" means all demand and time deposits, including deposits of the United States government, state and political subdivisions, other financial institutions, public libraries, educational institutions, religious institutions, charitable institutions, and certified and affixed checks.

SECTION 2. A. "Deposit" means all demand and time deposits, including deposits of the United States government, state and political subdivisions, other financial institutions, public libraries, educational institutions, religious institutions, charitable institutions, and certified and affixed checks.

SECTION 3. Rate of Franchise Tax. A. The rate of the franchise tax imposed on financial institutions shall be twenty-five thousandths of one percent (0.025%) of the deposits located in the jurisdiction of Nicholas County.

SECTION 4. Administration. A. The Kentucky Revenue Cabinet shall certify to the local jurisdiction the amount of deposits within the jurisdiction and amount of the tax due.

SECTION 5. Due Date. A. The tax bill shall be due January 31 of the next year after it has been issued; thereafter, the bill shall be delinquent and subject to a penalty of two percent if paid within thirty (30) days.

SECTION 6. Records. A. It shall be the duty of the County Treasurer to collect and account for the franchise taxes imposed by this ordinance. The treasurer shall keep records of the amount received from each financial institution and the date of receipt.

SECTION 7. Effective date. The provisions of this ordinance shall become effective upon passage.
