The Cats stormed down the court, taking the ball hand and taking a five-point lead over Utah.

Heshimu Evans went to the line for Kentucky with 29 seconds on the game clock to bring the lead up to 24-6.

Sheppard gave Kentucky a nine-point lead and pushed the Cats to the final win in the 1998 NCAA Men's Basketball Championship with a score of 78-69.
