Early results of FEMA pilot project on track

Officials of the Federal Emergency Management Agency (FEMA) announced today that a new process for delivering public assistance, being pilot tested in Kentucky, is expanding federal disaster funding to state and local governments for uniformity and consistency, the agency began reorganizing the public assistance program to make it more efficient and to get greater emphasis on customer service.

Government Paul Patton agreed to the Commonwealth's participation in the test, which, to date, has awarded over \$1.6 million to state and local governments for the repair and restoration of public facilities damaged by the severe storms and flooding that struck parts of southern Kentucky beginning April 18.

Officials from FEMA and Kentucky's Disaster and Emergency Services held briefings in mid-May to assist local officials in completing the documentation required for assistance under the new process. We are pleased to have awarded over a million dollars over the summer and to see applications received for funding, sometimes as soon as 10 days after submitting their paperwork.

The pilot test offers FEMA officials the opportunity to simulate proposed changes to the program and make refinements prior to nationwide implementation.

By improving the process, we do a better job in times of crisis and can help make recovery from disaster quicker and less difficult," said Adamski.
