An Ordinance Annexing to the City Property of The Nicholas County School District Finance Corporation, and Old Paris Road Investments LLC, West and North of the City, Containing 68.272 Acres and 6545 Acres More or Less.

BE IT ORDAINED BY THE CITY OF CARLSLE, KENTUCKY:

SECTION 1. That the City hereby annexes to the City boundary those certain tracts of land west of the City and lying North of KY Hwy 36 and KY Hwy 32 containing 68.272 acres, and 6545 acres, more or less, which properties are owned by the Nicholas County School District Finance Corporation, and Old Paris Road Investments LLC, respectively.

SECTION 2. That the properties are adjacent to the City urban in nature, and it is desirable for the City to annex such tracts.

SECTION 3. That the tracts to be annexed are more particularly described in Annex, "Legal Description, City of Carlisle, Kentucky Annexation," attached hereto and incorporated herein by reference.

SECTION 4. That following a public hearing and the recommendation of the Planning Commission pursuant to KRS 100.209, the zoning for such annexed tracts shall be as determined by the Planning Commission.

ORDINANCE 2 - 2000

AN ORDINANCE ANNEXING TO THE CITY PROPERTY OF ANNA MARY C. HAMMONDS, GLADYS C. SHROUT, AND JACK CLINKENBEARD, WHICH PROPERTY IS ADJACENT TO THE CITY OF CARLSLE, KENTUCKY, AND GENERALLY SITUATED NORTH OF THE CITY BOUNDARY, CONTAINING 6.47 ACRES, MORE OR LESS.

BE IT ORDAINED BY THE CITY OF CARLSLE, KENTUCKY:

SECTION 1. That the City hereby annexes to the City boundary those certain tracts of land north of the City boundary containing 6.47 acres, more or less, which property is owned by Anna Mary C. Hammonds, Gladys C. ShROUT and Jack Clinkenbeard, respectively.

SECTION 2. That the property is adjacent to the City urban in nature, and it is desirable for the City to annex such tracts.

SECTION 3. That the owners of the property to be annexed, consent to and have requested the City of Carlisle to annex their property, by Affidavit of Consent to Annexation, attached hereto and incorporated herein by reference as Exhibit #1.

SECTION 4. That the tract annexed is more particularly described in "Exhibit A, Legal Description, City of Carlisle, Kentucky Annexation", and in accordance with the plat described as "Property of Vincent G. Wells and Kimberly D. Wells, Husband and Wife, Incorporated herein by reference, as "Exhibit B".

SECTION 5. That following a public hearing on March 1, 2000 and the recommendation of the Planning Commission, pursuant to KRS 100.209, the re-zoning for such annexed tract shall be Residential District (R-2).

SECTION 6. This Ordinance shall become effective upon its passage, approval and publication as required by law.

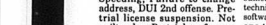
