

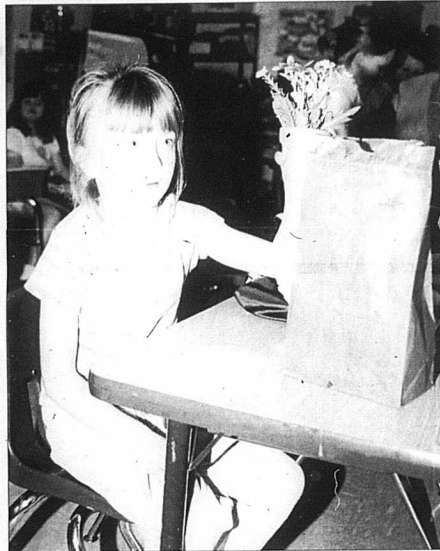

JUDGE FROM FRONT

in this case," Mains wrote. Mains essentially disqualified himself from further deliberation in the case and the Chief Regional Judge of the Mountain Region is requested to appoint another judge to hear the case against Leonard Treadway, 57, of Sharpsburg, who is accused of buying votes for a not guilty verdict. Commonwealth Attorney Woodson Wood decided to retry the case. The first trial resulted in a

mistrial since the jury could not reach a unanimous verdict. The case is before the court now for a decision on a motion for change of venue to move the trial away from Owsingville.

As part of the prosecution's motion for a change of location for the trial, Woods referred to a confrontation that occurred between Judge Maze and himself during the last trial while the jury was deliberating.

Woods wrote in a motion for change of venue that Judge Maze's relationship with

potential jurors as a sitting judge could jeopardize the Commonwealth's ability to obtain a fair trial.

Additionally, the defendant has requested all investigations concerning Kentucky State Police Detective Mike Martin and Donald Maze.

At the trial, another underlying issue which came up was the allegation by Donald Maze that Martin was using this case as a personal vendetta to make him look bad, Mains wrote.
