NCHS Freshman Kyle Campbell Campbell part of Top 15

Already well known within his district and region, Nicholas County's Kyle Campbell is starting to make a name for himself on the state level and was announced this week as a member of the "Best of the Bluegrass" Class of 2010 by KentuckyPrep.com.

Campbell, a 6-foot-1 junior, was ranked #10 in the Class of 2010 Top 15, one spot behind Louisville Trinity's Josh Sewell, but ahead of Shelby Valley's Taylor Newsum and South Laurel's Matt S. John, two players who helped their teams to the Sweet 16 this season.

Campbell was one of the 10th Region's top performers this past season with averages of 16.1 points, 5.5 rebounds and 2.2 assists per game for the Bluejackets, leaving no doubts that he is one of the better freshmen in Kentucky.

"I think Kyle is very worthy of that Top 10 ranking," said Nicholas County coach Michael Cofer. "I don't know of any other freshman that we have played against that did as much for his team as Kyle did for us."

Becoming one of the top players in his class hasn't been easy for Campbell, who has elevated his game with a lot of hard work and countless hours in the gym and weight room. It is very common for him to be the first one on the practice floor and also the last one to leave.

"Kyle is a gym rat," said Cofer. "He's there every day and he is always willing to work on every part of his game. Kyle is a competitor. He just wants to win," added the Nicholas County coach. He is one of those players who wants the ball in his hands for the last shot. He plays strong and is aggressive when taking the ball to the hole. He has a good outside shot, so teams have to come out and guard him all over the floor."

While he is in the lower half of the Class of 2010 Top 15 right now, Campbell has the skills and work ethic to continue to climb in the rankings. There is no doubt that he is just now starting to scratch the surface of his potential.

"Kyle has the potential to become a great player for us and to be one of the best players in the state," said Cofer. "Like all freshmen, he needs to get stronger and quicker and needs to improve his ball handling and gain consistency in his outside shot."

Campbell isn't just a rising star on the basketball court, he is also a standout baseball player at Nicholas County as well as a star student. He's someone that the community can be proud of.

"Kyle is a very polite and quiet young man. He is a great student and even better person to be around," said Cofer. "Kyle is one of those players that makes our job as coaches easier."
