wooden structure, which spans Johnson Creek just off of Ky. 1029 in Robertson.

"We've worked together for over 30 years," Gratton, the head of Arnold Grant Associates, Inc. of Henderson, N. H. said of his experience with Fischetti, who supervised the bridge's reconstruction.

Local authorities, including author Miriam Woodfill, believe the Johnson Creek Covered Bridge was built by Jacob Bower between 1862 and 1870.

"The bridge to still be standing after all this time shows that the original builder was pretty good," Gratton said.

Gratton further said he will build the bridge's reconstruction in the end of May and said he was looking forward to re-opening engineering issues as needed. He is my very best there in the opinion.

"On my last visit I spoke to a man who said he remembered driving a team of oxen over the bridge in 1910," Gratton said.

The bridge, described as a Smith Type IV design, was closed and bypassed in 1966 for safety reasons.

Funding for the first phase of the Johnson Creek Covered Bridge restoration project was provided through a grant from the Federal Highway Administration's National Covered Bridge Preservation Program and will include the alignment of the bridge, and repairs to the lower chord and diagonal members.

Although earlier covered bridge projects met with controversy due to the replacement of original material, the Kentucky Transportation Cabinet now places emphasis on restoration over replacement, with guidelines and standards for covered bridge projects being held in compliance with design documents provided by the Burlington Charter for the Preservation of Historic Covered Bridges.

Officials are inviting the public to attend an informational meeting to discuss the project, scheduled for Thursday, May 10, 10 a.m. to 7 p.m. at the Robertson County Public Library, Kentucky Transportation Cabinet offices, members of the Buffalo Trace Covered Bridge Authority, Kentucky Heritage Council, and the design-build team will be available to answer questions at the meeting.

Work will begin soon to bring back to life the Johnson Creek Covered Bridge located in Robertson County.
