

SPORTS Fairview stops Jackets, 27-0

WESTWOOD - Nicholas County's defense played exceptionally well in the first half, and the offense moved the ball well, but could not score and the Eagles downed the Blackjackets 27-0 in a hard fought game.

The second half was marred by a melee involving both teams, as both teams had players ejected from the contest.

After stopping Fairview's opening drive on a fumble recovery, Nicholas County downed the Fairview 18 before turning the ball over on downs back at the Eagles 30.

Four plays later the jackets fielded a punt from Fairview and went back on offense.

The Jackets took the ball at their own 45 and move it to Eagle territory before turning the ball over.

Fairview finally managed a drive to the end zone, aided by a penalty to score on a two yard run by 63 full-back Dennis Armes. The point after kicked half 47.0, as it was retained until a hard fought game.

"We played real well the first half," said NCHS Head Coach Robert Hopkins.

"We let them have a long run. They (Fairview) got it down there first and goal on the four and it took them four tries to get it in. Armstrong was a strong running back.

"The score is 7-0. We get three straight first downs, first and 10 on the 20, we had an illegal procedure and then on the next play we had a fumbled snap. We had two plays like that and it's third down and long.

"We're not a good third down and long team. It goes

to what we have talked about in the past. We need to be able to make a lot of athletic ability plays," Hopkins added.

Fairview scored a second quarter with 6:42 to go in the third quarter on a 16 yard pass play.

"The Eagles added two more scores in the second half to set the final margin of 27-0.

"We're still an old style football team. It's not by choice. You have to do what you can. You don't want to try and do things you're not good at," Hopkins said.

"The first two and a half quarters we really couldn't have played any better. All of our receivers are new. We had five minutes in young and then on the next play we just lost a knock to the simple stuff and make it what we're doing. They are better than I thought to us. We had it handed to us on the offense line. Our defensive line never or eight plays down because of their season's rest. "All of their kids know where they're going. We have to learn assignment, offensive football, and we're not doing it well."

"I think offensively well because of them. We have to, because the other side (against Fairview) the defense we out there a lot. We have to have kids step up. We have to get back to the type of drives we had against Jeffersontown and West Carter."

"This Friday night the Jackets entertain Paris in the season's first home game."

Last year the Greyhounds claimed a 40-8 decision over Nicholas County in Paris. This year, while Nicholas County is the 0-3. The Greyhounds are 0-1-2.

Cagers face tough schedule home and away

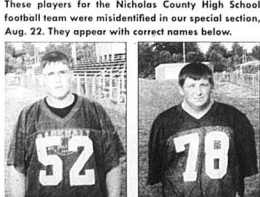
The Nicholas County High School boys' basketball program has finalized and released its schedule for the 2007-08 season.
