From what I have been able to tell here is how it works. If you work 40 hours a week and make \$10 an hour that means on average you will make just over \$1600 per month. If you have a child that you support if you make more than \$1404 per month you are not allowed to receive any assistance from the state.

So you work every day, and do the very best you can to raise your family but because you have worked hard to get ahead you get no assistance. I see why people don't work.

On the other hand if you do not work, stay at home, off another program. If you get government assistance of more than one form. Food stamps, a monthly check, heating assistance, medical assistance - and you never have to get up and go to work. Just sleep in until you're ready to get up.

For those who are unable to work, those who have medical problems, those who are unable to find a job - I have
