Robinson enters not guilty plea

A young Carlisle man appeared in Nicholas County District Court Jan. 2 and entered not guilty pleas to 55 felony counts of violating graves and five counts of criminal mischief, third degree. Jesse James Robinson, 19, of Carlisle, appeared before Honorable Judge Jay Delaney and entered not guilty pleas during his arraignment. Judge Delaney appointed a public defender to Robinson and modified his bond to \$25,000 cash, with ten percent of that amount being authorized.
