

# DIRTY TACTICS BY PROMPT DESTROY NEWBERRY'S BID IN CLOSING DAYS OF FAMILY COURT ELECTION CAMPAIGN

Three months ago I drove to the State Capitol in Frankfort to declare my candidacy for Family Court Judge. A month later, over Labor Day weekend, I loaded up my trailer (and/or what my wife Kim affectionately refers to as my "suspender campaign trailer") with signs, brochures and other materials and officially launched my campaign by going door to door event to event, from one community to the next, introducing myself and asking for your support and for your vote. And now after all the votes have been cast and the ballots counted, I want to give special thanks to the many wonderful people I've met, to recognize the hard work and efforts of those local businesses who have worked closely with me to provide the materials and resources I needed to support my campaign, and to make a few final remarks.

I am deeply humbled by and forever grateful to the many wonderful people I have met and spoken to as I've traveled through Harrison, Nicholas, Pendleton and Robertson counties, and to the nearly 5,000 people who voted for me. While it is impossible to personally thank everyone right now, I would be remiss if I did not publicly thank Dr. Ed Ford and Dr. Leon Rigg for their enthusiastic endorsements. I was truly honored to have their support and encouragement throughout my campaign.

I had the sincere pleasure of working with several local businesses in the selection, development and creation of the campaign materials which I used and would like to recognize those who stand out for their exceptional service, including:

In the last few weeks of the campaign, one candidate ran advertisements in the local paper claiming that the only Kentucky case that could lead where I was an attorney involved my neighbor over a boundary dispute. Again, this false claim either represents a purposeful misrepresentation of the facts, or my very legal reason on behalf of a candidate claiming 5 years experience as a staff attorney for the Court, as a review of the recent Court records show that I was actually currently involved as an attorney in three Harrison County cases, as well as current cases and representing clients in McCracken, Hopkins, Henderson, Jefferson, Fayette, Boone, Campbell, Nicholas and Harrison Counties. In fact, my Kentucky practice over the years has been quite extensive, having practiced law in at least 29 Kentucky Counties. Despite false rumors to the contrary, I am a licensed Kentucky attorney, not an out of state Ohio attorney. I am, however, also licensed in Ohio and Pennsylvania and I have practiced law in several other jurisdictions across the country.

The false accusation in the same newspaper regarding me using my neighbor stems from a neighbor claiming, nearly three years after I purchased our farm, that I owned approximately one acre of his neighbor's farm. After I thoroughly researched his claim and no firm had been made that I did indeed own property, I showed my neighbor my research and suggested that he drop his claim, or that he ask Judge McGinnis to decide the issue. I even offered to pay his filing fees for his request. My neighbor declined my suggestion. As a tension increased, I in an effort to diffuse the situation and maintain good neighborly relations, offered to pay my neighbor \$4,000 for the release of his claim on my property. He refused, and instead insisted that I pay him \$25,000 for the property which I knew belonged to me. It was only after that point that I felt present this matter to the Judge McGinnis for a determination of the boundary dispute. When I did so, the Judge ruled in my favor, declaring the property to be mine. The other candidate also failed to advertise the fact that my neighbor sued me for asking Judge McGinnis to determine who owned the property. My neighbor, through his attorney, claimed that as an attorney I was negligent and that I should have known that I did not own the property.

Throughout my campaign, I focused on my positive ideas for improving the Family Court system, and my qualifications for making those improvements. I would also like to congratulate both Mr. Edwards and Mr. Branson for also conducting dignified and respectful campaigns.

Unfortunately, my opponents chose a different tactic, by anonymously making false accusations and spreading lies about me in order to defeat my candidacy. It is ironic that my opponents would stoop to these tactics. As Family Court Judge, I often hear of false accusations and lies made by opposing parties in an attempt to gain an advantage over one another; the Family Court Judge is often the one who must resolve these false accusations and lies to get the truth.

Do we really want a Judge who engages in or condones such activity or do we want a Judge who himself was a victim of such activity and personally knows just how every accusation is true. Which Judge do we want to protect our rights?

One of the candidates for Family Court Judge came on the WCTR radio station and blatantly accused me of trying to buy the Family Court judge seat by putting out thousands of signs and handing out thousands of trinkets. This was a serious and false accusation, as vote buying is completely illegal. Unlike others, I did not accept contributions from anyone. In fact, when asked by supporters if they could contribute to my campaign, I always declined and instructed them to instead make a donation to a local shelter for abused women. Birthdays, all of my purchases were made from local business people in support of them and their families. In addition, unlike the other candidates, virtually all of my signs were personally erected by me, and unlike the other candidate who falsely accused me of attempting to buy the Family Court judge seat, said signs and signs which were purchased and provided by unknown people in an attempt to obtain my vote, all of my signs fully complied with the law, and disclosed who paid for 100% of my campaign.

I approached my campaign as your next Family Court Judge just as I have tackled the other major

undertakings in my life, such as my education, my family, my faith, my law practice and my community service. Fully committed, dedicated, with hard work, thoroughly prepared, and with passion. I was a straight A student in college, where I graduated first in my class. Furthermore, I completed my college degree in just three years, sometimes taking as many as 23 credits and 4 courses per semester to do so. I earned several full scholarships to law school, where I also ranked first in my class and earned the college of law's highest honors and awards for professional responsibility, negotiation and great law. In fact, in 1987, I became the first and only student in the college of law history to successfully answer the question presented on the final patent law examination. I later completed a post-graduate program at Harvard Law School. And I was later offered the opportunity to teach the college of law's course on professional responsibility. Since graduating from law school, I have built a very successful private law practice representing clients here in Kentucky and all over the Country.

I would have brought those same qualities and traits: commitment, hard work, thorough preparation, dedication and passion, to my job as your next Family Court Judge.

One of the candidates claimed me for being from Cincinnati, and not originally from the area. Oddly enough, that candidate is also not originally from the area. Nor should that make any difference, as I am the other candidate to be from the area, and Judge Malher, the retiring Family Court Judge, is from another Ohio River city, Portsmouth, Ohio. Coincidentally, Judge Malher and I are both graduates of the University of Cincinnati College of Law, the nation's 4th oldest law school.

The campaign to destroy my reputation did not end there. Hundreds of additional anonymous letters were delivered to the editors of the local newspapers, my fellow church members, my veterinarian, the presidents of the local Rotary Club, and supporters of mine with signs in their yards. These letters arrived in manila envelopes bearing no handwriting, but out out and gave addresses, with no return address, much like black letters seen in movies and on television. Even Kirk Christen, the popular host of WCTR's "Coffee with the Country" program, found one of his mailboxes tagged to his door. Both Mr. Christen and several of the Harrison County Magistrates immediately contacted me and expressed their outrage and disgust with such a glib and cowardly attack upon me.

Obviously, these anonymous letters were calculated to be delivered at a time (Thursday afternoon) after the Thursday morning deadline for all publications, so I would not have an opportunity to respond to these false accusations and lies prior to the election the next Tuesday. In fact, when the community received the Harrison County Shopper on Saturday, there was no denial from me of these lies and false accusations. Instead, the readers and voters by Barbara Trull's campaign advertisement to learn the "TRUTH" about the candidates by urging them to seek the very same people that just received the anonymous letters!

By Friday afternoon, it was reported to me that the lies about me had already been spread to the downtown lunch crowd. By Saturday, I began to notice fewer and fewer books of the horn from well-wishers and supporters; as I walked the streets around town, carrying by Sunday, almost all of my signs had been removed from the businesses and yards of my supporters. On Monday, Dr. Rigg's newspaper reported that they could no longer vote for me as a result of receiving anonymous telephone calls, letters or faxes from a convicted criminal. At 7:30 a.m. Tuesday morning, the day of the election, I received a telephone call from someone from my church telling me that she was calling to tell me that she could no longer vote for me because of what she had heard about me. After explaining what she had been told were lies, she thanked me and said she was going to vote for me. Unfortunately, that was the only call I received from anyone asking me about the terrible lie that had been anonymously spread about me since the Thursday prior to the election. Perhaps the most telling thing that I have heard about the effects of the malicious and anonymous attacks upon my reputation was on Wednesday, the day after the election, a friend of mine was talking to one of his friends and asked her about the election results. Her response was "I didn't care about any of the local candidates, except I just wanted Peter Newberry to lose." Shocked by her response, my friend asked her why, and she explained that she did not know me, but she was reading Barbara Trull's campaign advertisements, urging voters to learn the "TRUTH" about the candidates by anonymously making false accusations and asking the people who worked at the Courthouse and she heard terrible things about me, and decided to do what she could to defeat me.

For the record, let me state the following facts to clear up the false accusations and lies which were maliciously and anonymously spread about me:

1. My wife Kim and I live on our farm in Squire, in Harrison County;
2. I am a licensed Kentucky attorney, not an out of state attorney with many current cases, not including Harrison County;

In fact, the Cincinnati Enquirer reported that I am the only person to successfully sue the City of Cincinnati for a path, after I demonstrated that the City knew about the large pothole for over six months, but failed to repair it despite hundreds of reports of damage to cars. The City was ordered to pay me \$15,000.00, which I then used to purchase, assemble and donate hundreds of bicycles for poor and disadvantaged children in Cincinnati and Northern Kentucky, which I personally delivered. The pothole was also repaired.

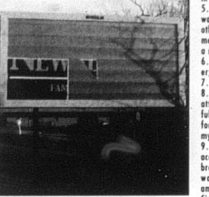
