Second Annual Veterans Day Program to be held

The Second Annual Veterans Day program will be held at the Neal Center on Saturday, November 8th, from 9:00 am until 5:00 pm. The program will honor the military veterans of Carlisle and Nicholas County. This year, the program will pay special recognition to the Nicholas Countians who fought and died in the First World War. Veterans' Day of 2008 marks the 90th anniversary of the end of that conflict.

A variety of memorabilia in collections will be displayed, including weapons, equipment, and other military artifacts, primarily from World War I and II.

Carlie's National Guard Unit will also showcase a Humvee and other modern military equipment. Veterans of all wars and eras are especially encouraged to attend, and are also invited to bring in and share any memorabilia that they may have from their time in the service.

Frank Mathias, Carlisle native and army veteran, will also be on hand to sign copies of his two books, The GI Generation and GI Dive. Mathias served in the 27th Division during World War II, and participated in the campaign to liberate the Philippines.

His books narrate his childhood in Nicholas County before the war, and his experiences as an infantryman and army band member in the Pacific Theater.

At 10:00 am, there will be a parade honoring all veterans. The parade will circle back around the courthouse square and end at the war memorial at the

Carlish Cemetery, where a special remembrance ceremony, including a color guard and bugler, will be held.
