

# Federal grant will help families with special-needs children, Rep. Overly says

Frankfort — A federal grant just received by the Kentucky Commission for Children with Special Health Care Needs will ease the concerns many Central Kentucky families may have about cutting through red tape, state Rep. Rianne Overly said today.

The \$90,700 grant from the U.S. Department of Health and Human Services will enable the commission to establish a 12 statewide Family-to-Family Health Information Centers for children 21 and younger, with Lexington being among the first.

The year-long grant, which could be renewed for two additional years, will be overseen by two co-directors who are themselves parents of special-needs children.

"Navigating our healthcare system is difficult under any circumstances, but especially for those families with special-needs children who require ongoing care," she said.

"This program, run by those with first-hand knowledge of what families by providing support and reducing the feelings of isolation."
