Lady Jackets shut out St. Patrick

The Nicholas County High School softball team blanked St. Patrick 5-0 on Saturday afternoon.

Wednesday (April 29) in the 10th Region All "A" Classic, winning for the seventh straight time this season. Nicholas County improved to 9-1 overall after posting the regional tournament win. Veteran Nicholas County softball coach Barry Bretz was pleased with the victory.

"We played well defensively and kept St. Patrick scoreless," said Bretz. "This was only St. Patrick's second loss of the season and both

Jackets enjoyed a balanced offensive effort en route to the win.

Shelby Brown pitched a complete two-hit game for the Lady Jackets. The veteran Nicholas County pitcher improved to 8-1 after claiming the win.

Nicholas County hasn't lost since falling to 38th District rival Harrison County in their third regular-season game back on April 16. The Lady Jackets followed a home game with a win at 38th District rival Harrison County, and are scheduled to host Harrison County on Thursday (May 7).

Megan Hunter

Nicholas County High School junior Megan Hunter has quietly put together a phenomenal track and field career. Hunter ranks as one of the top female high school throwers in the state. Her efforts in the discus and shot put events have sent her apart in numerous meets over the course of the past three years. She is looking to compete in the state track and field tournament for a third straight year later in the season. Hunter finished last season just shy of claiming a state championship.

"Megan is an outstanding performer in the discus and shot put," said Nicholas County Coach Greg Letcher. "She competed in the discus competition at the state track meet both her freshman and sophomore years. She was state runner-up in the discus, being beat on the final throw of the competition." Letcher expects Hunter to contend for state championships in her two events this season.

"Hopefully, this year, Megan will get the competitive juices flowing and strive to work hard enough to get back to the state in both the shot and discus and win a state championship," said Letcher.

A two-spot standout, Hunter averaged 37 points and 3.5 rebounds per game for the Lady Jackets on the basketball floor during the 2008-09 hoops season. Hunter has paced the NCHS track and field program throughout the current season. She is one of the most successful track and field athletes in NCHS history.



Shelby Brown

One of the 10th Region's most experienced softball pitchers works out of the circle for the Nicholas County High School softball team. Junior Shelby Brown took on a prominent role as pitcher for the Nicholas County High School softball program in junior high. She has helped Nicholas County to regional and sectional championships as part of a stellar career that continues now during her junior campaign. Opposing teams have become quite familiar with Brown and her strong pitching.

"Shelby has been our starting pitcher since her eighth grade year," said Nicholas County Coach Barry Bretz. "She has been on the mound for two regional and sectional title wins."

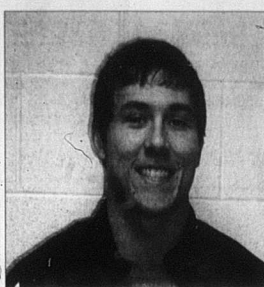
Brown has plenty of state tournament experience on her impressive softball resume. She has faced well against competition from other parts of the state.

Kyle Campbell is arguably one of the top student-athletes in Nicholas County High School history. A junior, Campbell has again made a smooth transition from the basketball court to the baseball diamond. One of the most prolific scorers in the NCHS boys' basketball program's history, Campbell is currently starting for the Jackets baseball team.

"Kyle is a very special player and person," said Nicholas County High School baseball coach Travis Sims. "Coach (Michael) O'Leary said it right in a couple of weeks ago. Kyle is one of the first ones to practice and one of the last ones to leave. As a coach that's what you want out of your players."

Campbell has showcased his versatility on the baseball diamond for quite some time now. The NCHS junior can play more than one infield position and ranks as one of the team's leading pitchers.

"Kyle plays second, shortstop, and pitches for us, so he is a very important part of our team," said Sims. "He has had a very solid year for us this year."

Campbell currently leads the NCHS baseball in the hitting department.

"Kyle leads the team in batting average and has done a very fine job on the mound," said Sims. "He has won five games this year pitching on the mound and we really relied on his arm with all the other injuries to other players."

The future is quite bright for Campbell. He has his senior year remaining in a stellar prep career.

"I look forward to having Kyle around for another year as the team will look for his leadership and dedication," Sims added.
