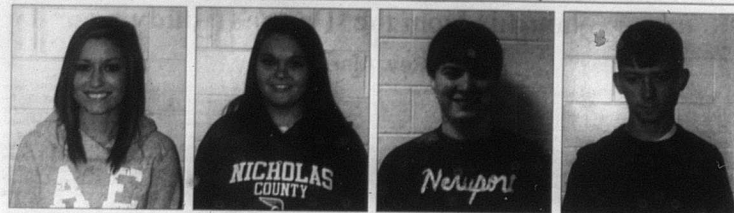

BOWLING GREEN, Ky. - The Kentucky Mesonet has expanded its wide range of instruments to include weather and climate monitoring network in Fulton and Harrison counties. The Mesonet stations collect real-time weather and climate data on temperature, humidity, solar radiation, wind speed and direction. Data is picked up and transmitted to the Kentucky Climate Center at WKU every five minutes. 24 hours per day, throughout the year and is available online at www.kymesonet.org. The Mesonet stations are located in Adair, Allen, Barren, Breathitt, Bullitt, Caldwell, Calloway, Casey, Christian, Clark, Crittenden, Henderson, Lewis, Metcalfe and Owsley counties. Site selection agreements have been reached in Clinton, Nicholas, Marion, Muhlenberg and Trigg counties. Negotiations are under way in hopes of securing sites in about 30 other counties, including Bell, Boyd, Harlan, Knott, McCreary, Nelson, Pendleton, Pike and Todd.
