A Carlisle man remains at large after Kentucky State Police officers with the Cannabis Suppression Team (CST) served a search warrant at his Carlisle home and found marijuana.

According to Kentucky State Police veteran Detective Keith Hensley of the state's CST, marijuana plants were allegedly found when a search warrant was served at the home of Dewayne Tackett, 38, of 1301 Myers Road on March 29.

"We found 29 plants, special lights, processed marijuana, and several weapons," Detective Hensley said, while he praised the efforts and assistance of local community leaders. "We couldn't be as effective without the assistance of local leaders in the community, such from an earlier crop." as County Attorney Dawn



Barterville fire destroys van

A fire Thursday night in Barterville destroyed a van, but led to no injuries and no additional damage.

Shane and Jodi Mattox had just returned home with their two children in a separate vehicle when a few minutes after their arrival a motorist pulled into their driveway blowing the horn and alerting the family that their 2006 Chevy Van was on fire.

Mr. Mattox ran inside and grabbed a fire extinguisher while his wife called 911.

Mattox had almost completely extinguished the fire when Nicholas County firefighters, under the direction of Fire Chief Mark Hughes, arrived on the scene and prevented additional damage form occurring.

"They arrived very quickly," Mattox said of the firefighters.

Mattox said he believed damage to the van was extensive, but expressed praise for the responding firefighters and the fact that none of his family members was injured and no additional property was damaged.
