Attempted burglary investigated

Carlisle Police Officers continue to investigate an attempted burglary of Soper's Family Drug Saturday morning.

According to police, an alarm drop alerted the Carlisle Dispatch Office of a possible breakin to the drug store at approximately 10:15 Sunday morning, and Officer Benny Buckler quickly arrived on the scene.

Once Buckler secured the building he was joined at the scene by Carlisle Chief of Police William Denton and Sgt. Darrell Layne and his K-9 Hancock.

A search of the building indicated the individual or individuals who at-

tempted to break into the drug store had left when the alarm sounded and just before police arrived.

"We have suspects and our investigation continues," said Buckler, who is leading the investigation.

Chief Denton said he was concerned, not just that the attempted burglary happened but especially at the time it happened.

"It's a pretty brazen act," he said. "Someone must be pretty desperate

for drugs to attempt this in broad daylight."

Fiscal court discusses resignation, county clerk audit

Members of the Nicholas County Fiscal Court met Sept. 14 and discussed several topics of interest, including the first reading of the tax ordinance, the resignation of the animal control officer and a 2009 discrepancy in the county clerk's audit.

Animal Control Officer

Tammy Williams offered her letter of resignation. Court members praised Williams' devotion to duty as the animal control officer and as an active member of the Nicholas County Animal Welfare Society. Williams' resignation will be effective Oct. 1.

A special called meeting of the Nicholas County fiscal Court was held Tuesday Sept. 28 to discuss the Animal Control

Officer position and strategy to fill the position as well as county related functions the officer will adhere to.

Discussion revealed that an audit of 2009 for the county clerk's office indicate that Doug Fryman had not paid himself approximately \$11-12,000 due to him. Fryman was absent from the meeting but magistrates and Judge-Executive Larry

Tincher indicated that since Fryman prepared his own annual audit, which he was required to follow and which they said Kentucky Revised statutes stipulated he had to pay himself and clerks with collected fees as they came in first, that the members of this or future fiscal courts weren't obligated to reimburse Fryman for the lost wages.

"The fiscal court is un-

der no obligation to pay him," Tincher said. "This is about doing the right thing and the right thing for us is to protect the tax payers of Nicholas County. The county clerk has to follow the law when it comes to paying himself and the deputy clerks."

Others agreed.

"I can't be for someone coming up short and then running to get the money out of the (county's) gener-

al fund," Magistrate Daryl Stacy said.

"When you (fiscal court members) approve the county clerk's budget, you need to make sure it balances out," Tincher added.

Members of the fiscal court also approved the first reading of the tax ordinance.

Greater details of the tax rate will be analyzed in future editions of The Mercury.

in 1784. "Edward Boone packed 22 horses in addition to the ones the family rode (in the 1779 move with Daniel Boone to Kentucky)." Draper Manuscripts, volume 23 C, deposition of Edward Boone Scholl.

The first week of October, 1780 at the Plum Lick, present See Road, Bourbon County.

The dog lunged and Daniel Boone fell to his side to avoid the vicious bite. He felt the dog's hot breath at his

throat as it snapped and growled.

In an instant the dog coiled and took a step forward, prepared to lunge again as Daniel Boone threw his rifle to his shoulder and fired. The heavy, lead musket ball struck the dog in chest, just below the neck. It fell on its side with a whimper while giving a few spastic kicks with its back legs before becoming still.

Daniel had just finished reloading his Kentucky Long Rifle, improvising the loading process when he dropped his ramrod as the Shawnee attack began.

He'd frantically whittled away at a cane sprig, quickly fashioning a make shift ramrod as he ran

from the warriors.

Daniel jumped over the dog and was 20 feet away in the midst of a large cane field when several shots were fired at him.

It was the second volley of shots coming from at least seven Shawnee men, perhaps as many as ten.

He could hear the banter and bawdy cat calls of several Shawnee warriors who were less than 100 yards away near the western edge of the large cane field that engulfed the terrain near Plum Lick.

They were standing over his brother Ned.

Even after Ned was dead they kept shooting him and laughing.

And the farther he ran through the vast cane field that marked the region of country, it seemed as if the laughter just kept growing louder

and louder.

He and Ned looked so much alike the warriors thought they had killed him instead of his younger brother.

They thought they had killed Daniel Boone or the big slow turtle, or Shell-tow-nee as his adopted tribesmen had called him in his past. He had earned the name of the Big Slow Turtle due to his slowness. And though a Shawnee musket ball which had shattered his ankle a few years earlier had left him slow, the wound had continued healing and he found himself now racing across the cane fields and circling back southwestward towards Boone's Station.

"What a horrible mess," he thought as he ran along at that steady mile-eating trot.

Edward and Martha had long made Wilkes County, North Carolina their home before listening to Daniel and going to Kentucky. Ned and Martha had six children, Charity, Jane, Mary, George, Joseph and Sarah, the youngest, who was eight-years-old. Edward was a community and church leader in North Carolina, but now he was just one more Kentucky corpse.

How could he tell his wife Becky?

How could he tell Becky's sister, Ned's widow and their six children that their daddy wasn't coming home ever again, and they would never see their loved one again?

How could he possibly tell them he'd gotten Ned killed?


Do you believe that you are living a good life and that everything you do is perfect and how God would want it?

We conducted our audit in accordance with auditing standards generally accepted in the United States of America, the standards applicable to financial audits contained in Government Auditing Standards issued by the Comptroller General of the United States, A and the Audit Guide for Sheriffs Tax Settlements issued by the Auditor of Public Accounts, Commonwealth of Kentucky. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statement is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statement. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

As described in Note 1, the Sheriffs office prepares the financial statement on a prescribed basis of accounting that demonstrates compliance with the modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America In our opinion, the accompanying financial statement referred to above presents fairly, in all material respects, the Nicholas County Sheriffs taxes charged, credited, and paid for the period May 30, 2009 through April 15, 2010, in conformity with the modified cash basis of accounting.

In accordance with Government Auditing Standards, we have also issued our report dated July 27, 2010 on our consideration of the Sheriffs internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on the internal control over financial reporting or on compliance. A Radiologist is a physician trained in the diagnostic and/or therapeutic use of X-rays and radionuclides, radiation physics and biology; a diagnostic radiologist is trained in diagnostic ultrasound and magnetic resonance imaging and mammography.

Q: What is Digital Mammography?

A: Digital Mammography is the latest technology in the detection of breast cancer. Digital Mammography uses computers and specially designed digital detectors to produce an image that can be displayed on a high-resolution computer monitor, and transmitted and stored just like computer files.

From a patient's point of view, having a digital mammogram is very much like having a conventional screen-film mammogram. Both film-based and digital mammography use compression and x-rays to create clear images of the inside of the breast. During all mammography exams, the technologist positions the patient to image the breast from different angles and compresses the breast with a paddle to obtain optimal image quality.

Unlike film-base mammography, digital mammograms produce images that appear on the technologist's monitor in a matter of seconds. There is no waiting for film to develop, which can mean a shorter time spent in the breast imaging suite.

Q: What are some of the benefits?

A: Unlike other parts of the body, the breast is composed mainly of soft tissue. When breast tissue is x-rayed, it creates an image that looks something like a smoky haze, making it difficult to see tiny "spots," called microcalcifications, and other subtle signs of early cancer.

With digital mamography, the radiologist reviews electronic images of the breast, using special high-resolution monitors. The physician can adjust the brightness, change contrast, and zoom in for close ups of specific areas of interest. Being able to manipulate images is one of the main benefits of digital technology. It can also greatly reduce the need for retakes due to over or under exposure. This potentially saves additional time and reduces your exposure to x-rays.

Edward Hopper and the American Dream

For today's column I wanted to show a correlation between the early 20th century painter Edward Hopper and the concept of the "American Dream". I have always had a vast interest in the idea and discussion of defining the American Dream and figuring out what it is, whether it be my personal understanding or just a general guideline for the country as a whole.




Throughout this article I plan to show you how the paintings of Edward Hopper give us a proper illustration of this perception of American emotion in a time of great adversity and determination. The perspective of the "American Dream" that both Hopper and I will be expressing to you today is not the white picket fence, smiles, happy faces, and success that one would typically associate with this idea, but instead the grit and fortitude it takes to achieve it.

Moving on to the connection between the artist's work and the magnificent balance of beauty and despair that comes with living life as an American. Throughout Hopper's works we see a recurring theme of despair mixed with a comfort in loneliness and thought. When looking at the various oil paintings, water colors, and sketches of this great man one can only feel a eerie sense of loneliness that manages to give you hope for the future. Although I feel that this saying is extremely cliché and over-used it is fitting to say that in each of Hopper's works that "a picture is worth a thousand words." There are so many things conveyed to the viewer in these works that there is no way I can possibly analyze every aspect even if I were to just choose one. Hopper evokes so many emotions in his work alongside great confusion that allows the viewer to make their own conclusions on the work.

To begin, I feel that it is only appropriate to give a proper introduction to Edward Hopper so that it will be easier to understand how his genius connects to this extremely broad subject. Hopper was an American painter who was predominately prevalent in the early 1900s, his style mainly revolved around depictions of American life, architecture, and landscape. During the early years of Hopper's life he struggled immensely with his dream of becoming an established artist until 1913 at the age of 31 when he would sell his first painting. With the exception of various travelling experience, Hopper lived in New York throughout the entirety of his life and much of his artwork reflected the lifestyle and culture of this area. Hopper also had a pension for the scenery and architecture of the New England area as well as the Atlantic coast.

My personal favorite and likely the most recognizable work by Hopper is Nighthawks (shown above) which was created in the midst of World War II (1942). The painting, Nighthawks, depicts a scene of an overnight diner with three patrons and a restaurant server, presumably very late into the night. The patrons of the diner are arranged in a very interesting fashion, with a male sitting alone (the apparent focal point of the work) with his back facing the viewer's perspective of the painting, the two others (an apparent couple) are settled at the other end of the bar, and lastly the res-



taurant worker stays slightly right of the couple. Nighthawks captures the essence of the concerns, worries, and woes of wartime and hard work.

When looking at Nighthawks we can see the struggle of Americans at the time and we can somewhat relate it to the troubles of the present. Uncertainty, fear, and confusion are the fundamental feelings I get when looking at this piece which ties to the point of my article. I personally feel that to accomplish the American dream we must undergo extreme hardships and this painting truly shows it. The man sitting alone in the painting is a model of the ambiguity of a worker trying to accomplish his goals especially in a time of hardship such as this. It is in this man alone we can make so many conclusions on what Hopper was trying to help us understand. It is my opinion that the man is simply sitting alone in thought, pondering over the concerns of tomorrow, and resting himself from the tribulations of that day. It is this unwavering determination for a better tomorrow that I feel mostly connects with the feeling of the American dream - that with hard work, determination, and careful thinking, anything can be accomplished.

Hopper's usage of a contrast in light and dark within the painting also attest to one of the possible hidden meanings I've theorized. I would suggest that within the diner the bright fluorescent lighting represents a comfort and security that provides from a cold, dark, and overwhelming world. A possible theme for Nighthawks that relates to our overriding idea of the American dream is the relief provided to us by freedom that we may someday conquer the cold, dark world through hard work.

As I stated earlier, the hope for a better tomorrow through hard work is what moves us closer and closer to the American dream. Nighthawks shows us

that although we may feel alone at a diner (in the world) that there are others right there with you (in the same situation and trials of life). The knowledge that you are not alone in accomplishing all the great things you want to within your life is what is truly amazing about America. The knowledge that although we are alone is put at ease by knowing that we all must all gain understanding of the dark world we live in.

Perhaps we as Americans today can take heed of all the things said in Edward Hopper's artwork. The knowledge that we live in a country that we always have the possibility of bettering our situation is the American dream within itself. In conclusion

of this article I feel as though it may not have been what you as the reader expected...because it turned out to be different than I had intended. Nonetheless, Edward Hopper was a great painter and an even greater person at seeing content of what he wanted to paint. Hopper depicted people and the ideals bestowed to us by growing up in America. If you get a chance you should check out other works by Hopper and you will learn through his depictions of the architecture especially his close ties to the American way of life. His depiction of people and towns shows great semblance of freedom and deep thought, both of which being extremely important to the culture of America.

Wildcat populations increase in county

Kentucky Wildcat (lynx, bobcat) populations are on the increase in Nicholas County.

A recent road kill specimen was preserved and checked with Kentucky Fish and Wildlife officers after discovering it shortly after it had been killed on the roadway near Myer's Station in north central Nicholas County last week.

Cody Emmons, who is a state worker who has been among the crew working on a bridge project in Carlisle in recent weeks, recognized the bobcat, which had been killed early last Thursday morning on the Myer's Road.

"We have a lot of bobcats in that section of the county," veteran Fish and Wildlife officer Herbert Booth said over the weekend.

Booth said officers have confirmed multiple sightings of bobcats and observed bobcats, both dead and alive in recent years in Nicholas County, particularly heavy in numbers near

the Clay Wildlife Management Area. Booth also said that officers receive all kinds of reports of a variety of animals including African Lions (it turned out to be a very large housecat)

and even get reports on Bigfoot sightings, but he said wildlife, including bobcats and black bear populations are indeed on the rise. "We've even had some credible reports of a mountain

lion (panther) being spotted in Harrison County," Booth said.

Jackets fall to Raceland in district game

Following a week off, Nicholas County returned to competition Friday night at home against Class A, District 5 rival Raceland. The Jackets, playing the role of host in their third straight game, entertained Raceland after opening the season 3-1. Nicholas County played well but couldn't fend off the visiting Rams. Raceland gradually pulled away from Nicholas County, defeating the Jackets 28-12. Nicholas County played longtime rival Raceland much closer than in previous outings over the years.

Raceland rolled up yardage, finishing with 431 yards of total offense. Nicholas County remained within striking distance of visiting Raceland despite being outgained by over 200 yards. Nicholas County finished with 214 yards of total offense in the district contest. Raceland picked up 215 yards through 30 rushing attempts. The Rams were 22-for-35 through the air, amassing 216 yards and three touchdowns with one interception. Caleb Popeled Nicholas County on the ground as

he rushed 15 times for 51 yards. Nicholas County faced plenty of resistance rushing the football. The Jackets were limited to 51 yards through 30 carries. Nicholas County quarterback Charby Pope completed 8-of-14 passes for 163 yards and two touchdowns. Austin Allison was 0-for-3 with an interception for the Jackets. Allison, however, recorded one reception for a game-high 81 yards. Five different Nicholas County receivers nabbed at least one catch. Matthew Kelly reeled in two catches for 37 yards

and one touchdown. Ty Warmouth made two receptions for 16 yards and one touchdown. Caleb Pope and Zach Howard also had one reception apiece for the Jackets. Warmouth averaged 36.6 yards per punt for the Jackets. Nicholas County dropped to 3-2 overall and 1-1 in Class A, District 5 after absorbing the loss. The Jackets had won three of their first four games, defeating Bath County, Fleming County and district counterpart Berea. Nicholas County will be back on the gridiron Friday night when it visits Lexington Christian for another key district game. The Jackets have additional regular-season games remaining with Lewis County (Oct. 8), Fairview (Oct. 15), Paris (Oct. 22) and Bracken County (Oct. 29). Kickoff for the Nicholas County - Lexington Christian district game is set for 7:30 p.m.

Shooting suspect arrested

Lexington police arrested the man they say is responsible for killing a Paris man and shooting a man and Nicholas County

ties. Jarrod Vice, 27, who has family ties in Nicholas County, was shot and wounded and his friend Jerry Waugh, 29, of Paris was killed following a shooting Sunday afternoon, Sept. 19 in

Lexington on Kenton Street.

Darrell Eugene Farrier, 29, of Lexington was arrested Thursday afternoon by Lexington Police officers and charged with murder, assault and robbery.

According to Public Information officer Sherelle Roberts, Vice and Waugh were in a vehicle driven by Vice when Farrier, who allegedly knew at least one of the men, got into the vehicle on Kenton Street.

Moments later Farrier demanded money and ultimately shot both Vice and Waugh in the head while he was still in-

side the vehicle, according to police.

Vice was able to drive from the scene a short distance and summon help from residents, moments after the shooting.

Waugh died Sept. 20.

Vice remains in the university of Kentucky Medical Center.

Lexington Police Detective Dave Richardson led the investigation and with the assistance of other detectives and Lexington police, arrested Farrier at 1:30 Thursday Sept. 23.

"He was arrested without incident," Roberts said.







Hughes faces several criminal charges

A Mount Olivet man arrested on Sept. 12 for 10 criminal charges is scheduled to have a preliminary hearing this week in Nicholas District Court. Dustin K. Hughes, 19, of Mount Olivet, was arrested by Fish and Wildlife Officer L. Clark and cited for ten violations including reckless driving, possession of a controlled substance not in original container, possession of a controlled substance (two counts), operating a motor vehicle while under the influence of alcohol/drugs, first offense; operating a motor vehicle on suspended license, fleeing

or evading police, resisting arrest, possession of drug paraphernalia, carrying concealed deadly weapon and tampering with physical evidence. Hughes allegedly "passed four vehicles at a high rate of speed" and "stayed in the wrong lane and nearly (hit) oncoming traffic", according to the arrest citation issued to Hughes.

Hughes' alleged reckless driving began at approximately 1:30 p.m., at Clark Hills in Nicholas County, six miles south of Carlisle, according to the arrest citation. Hughes failed sobriety field tests and was found to be in possession of drugs and drug paraphernalia, according to the ar-

rest citation. Hughes allegedly had pills in a plastic bag and a "spoon" on his person during his traffic stop. After failing the field sobriety tests and placing the pills in the bag on the hood of his 2007 KIA, Hughes allegedly grabbed the pills and ran. "Subject grabbed his bag of pills off the hood of my vehicle and ran," Officer Clark wrote on Hughes' citation.

Clark and Carlisle Chief of Police William Denton chased and apprehended Hughes after a race of approximately one-half mile, according to the citation. "Subject fought while being handcuffed" the citation reads regarding Hughes' alleged resisting arrest charge. Hughes also had "brass knuckles" in his pants pocket, according to his arrest citation. Hughes was taken to

Bourbon County Detention Center where he remains lodged. He was arraigned following his arrest and Public Defender Matthew Perdue was assigned as his attorney, according to court records. Several of Hughes' charges are felonies and those charges will be bound over to a future Nicholas County grand jury if District Judge, Honorable William Kuster, finds probable cause following the preliminary hearing Wednesday Sept. 29.

All persons are innocent until proven guilty or pleading guilty.


